Cosmos Group Holdings Inc. (fka Safe & Secure TV Channel, Inc. (SSTV)) Name Change and Other Corporate Matters

January 6, 2017 – [Hong Kong, S.A.R.] Safe & Secure TV Channel, Inc. (SSTV) announces that it has changed its name to Cosmos Group Holdings Inc. (COSG) and filed its Certificate of Amendment with the Nevada Secretary of State effectuating the change effective February 26, 2016. The name change and related symbol change to COSG were approved by the Financial Industry Regulatory Authority (FINRA) on March 31, 2016.

Increase in Authorized Capitalization

On May 2, 2016, COSG filed a Certificate of Amendment with the Nevada Secretary of State amending its Articles of Incorporation to increase the number of its authorized common stock, par value \$0.001, from 90,000,000 shares to 500,000,000 and its preferred stock, par value \$0.001, from 10,000,000 to 30,000,000 shares.

Resignation of Directors and Chief Financial Officer

Effective September 27, 2016, Peter Tong, our Chief Financial Officer, Secretary and director, and Calvin Lai, our director, resigned from their positions with the Company. The departure of Messrs. Tong and Lai were for personal reasons and not due to any disagreement with the Company on any matter related to the Company's operations, policies or practices.

In connection with the resignations, Miky Wan, our Chief Executive Officer, was appointed by the board of directors to serve as the interim Chief Financial Officer, and Connie Y.M. Kwok was appointed to serve as the Secretary of the Company.
