Health Canada has issued a supplement to their **Good Production Practices** (GPP) that includes new sanitation requirements. Canada is raising the bar for manufacturing standards for **Medical Cannabis Facilities**. Cannabis Clean, a wholly owned subsidiary of BLDV will soon be releasing their new standards based on the **Good Agricultural Practices** (GAP) and the **Good Manufacturing Practices** (GMP) that are being developed in Israel as part of the move toward bringing

Cannabis Manufacturing in line with other Biotech Industries. Cannabis Clean will use these new standards as the core of their new customized offering being launched on November 1, 2017. The new sanitation standards developed in Israel will meet the requirements of Health Canada.
