Since the last report filed by Special Situations under Part 4 for the Issuer, there is a net increase in Special Situations’ holdings of 2,644,200 common shares (“**Shares**”) and 250,000 common share purchase warrants (“**Warrants**” and together with the Shares, the “**Securities**”) of the Issuer, resulting in a net decrease of 0.54% in Special Situations’ securityholding percentage for that class of the Issuer’s securities.

Special Situations holds 18,495,500 Shares and 250,000 Warrants of the Issuer, representing approximately 17.06% of the issued and outstanding Shares of the Issuer.
