Puration, Inc. is a water purification company that designs, develops, engineers, produces, markets, and distributes personal and group systems that filter, purify, clean, extract or otherwise improve the quality of water on a cost effective, affordable basis, with a minimum of environmental impact. Resulting from our own design and engineering, our water purification systems include personal water filter bottles, collapsible water pouches, replacement filters, and travel filters.

Puration's products consist of systems that filter, purify, clean, extract or otherwise improve the quality of water on a cost effective, affordable basis, with a minimum of environmental impact. These systems include multi-user faucet-mounted and hand-powered purification units, such as shower head filters, backpack units, and portable systems capable of producing up to 35 gallons of potable water per hour from contaminated water, as well as individual or personal water filter systems, such as water filter bottles, collapsible water pouches, replacement filters and travel filters.

Puration provides several personal-use water filtration systems. Personal water bottles with a Level 1 filter reduces chlorine, bad taste and odor, with the Level 2 filter, removes significant

proportions of heavy metals, including lead, mercury and copper. Level 1 and Level 2 filters are also available in a collapsible pouch which can be folded when empty and carried in a pocket or small purse. Puration's basic water bottle comes in a 24 ounce size and fits in automobile cup holders and bicycle racks. The bottle also comes in a 30 ounce canteen shape. Puration's biological bottle has an additional filter, a biological filter, which removes bacteria, cysts, cryptosporidium and protozoa from contaminated water.

A user of these bottles simply adds water to the bottle and the bottle filters the water as the water is consumed. These products, depending on the product, can filter from 40 to 200 gallons of water before the filter needs to be replaced. The company believes that most of the customers for these personal-use and small common use water filtration systems are individuals in developed countries who wish to improve the taste, odor, or safety of the water supplied by their municipal or private water system. They should purchase our products to reduce the bad taste or odor caused by chlorine, algae, or chemicals such as iron and sulfur.

Compared to purchasing bottled water for consumption, our personal water filter products are much more economical. The products, especially the biological filter bottles, are also beneficial for individuals engaged in sporting activities, travel or recreation in remote areas. Certain customers may use these bottles when traveling to avoid the diseases attributable to bacteria-infested water. Disaster recovery teams and military personnel are prime examples, as well as missionaries and non-governmental agencies active in remote areas of the world.
