A. ORGANIZATION

NanoTech Entertainment, Inc. (“NTEK”) was incorporated under the laws of the state of Nevada on July 15, 2004. The Company operates as a manufacturer and developer of technology, television content, consumer goods, mobile applications, and consumer software. The company generates revenue from a mixture of licensing products to third parties for manufacturing and ultimate distribution as well as the manufacture and sale and rental of products directly to the consumer.

B. SIGNIFICANT ACCOUNTING POLICIES

USE OF ESTIMATES

The preparation of the Company’s financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates. The Company’s periodic filings with the Securities and Exchange Commission include, where applicable, disclosures of estimates, assumptions, uncertainties and markets that could affect the financial statements and future operations of the Company.

CASH AND CASH EQUIVALENTS

Cash and cash equivalents include cash in banks, money market funds, and certificates of term deposits with maturities of less than three months from inception, which are readily convertible to known amounts of cash and which, in the opinion of management, are subject to an insignificant risk of loss in value. The Company’s cash balance totaled \$6,895 as of June 30, 2016.

INVENTORY

The Company’s inventory is stated at the lower of cost or market using the FIFO costing method. Inventory on hand totaled \$987,940 at June 30, 2016 and consisted components and finished goods and equipment available and ready for sale.

PROPERTY AND EQUIPMENT

The Company’s property and equipment is comprised of office and computer equipment, which are stated at cost. Depreciation is calculated over the estimated useful lives ranging from 3 to 7 years using the straight – line method. The Company has \$1,280,706 in fixed assets, which had accumulated depreciation of \$594,387 as of June 30, 2016.

SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

REVENUE RECOGNITION

Revenues are recognized when risks associated with ownership have passed to unaffiliated customers, and when all criteria of ASB Topic No. 605 (SAB Topic 13) have been met. Typically, this occurs when finished products are shipped, or media content is delivered.

RECENTLY-ISSUED ACCOUNTING PRONOUNCEMENTS

In June 2009 the FASB established the Accounting Standards Codification ("Codification" or "ASC") as the source of authoritative accounting principles recognized by the FASB to be applied by nongovernmental entities in the preparation of financial statements in accordance with generally accepted accounting principles in the United States ("GAAP"). Rules and interpretive releases of the Securities and Exchange Commission ("SEC") issued under authority of federal securities laws are also sources of GAAP for SEC registrants. Existing GAAP was not intended to be changed as a result of the Codification, and accordingly the change did not impact our financial statements. The ASC does change the way the guidance is organized and presented.

E. STOCKHOLDERS' DEFICIT

The Company has authorized 2,010,000,000 shares of common stock with a par value of \$.001, and preferred shares of 5,000,000 total issued. As of June 30, 2016 the total shares issued and outstanding was 1,996,019,551.

During period ending June 30, 2016, the Company issued one convert able note payable to Royal Capital Group for cash invested totaling 226,500. During the period ending June 30, 2016, the Company issued a convertible note payable to Michael Steele for cash invested totaling \$60,550.

G. INCOME TAXES

The Company recognizes the tax effects of transactions in the year in which such transactions enter into the determination of net income, regardless of when reported for tax purposes. Deferred taxes are provided in the financial statements under ASC Topic No. 740 to give effect to the resulting temporary differences which may arise from differences in the bases of fixed assets, depreciation methods, allowances, and start-up costs based on the income taxes expected to be payable in future years.

H. GOING CONCERN CONSIDERATIONS

The Company's financial statements have been prepared using accounting principles generally accepted in the United States of America applicable to a going concern, which contemplates the realization of assets and liquidation of liabilities in the normal course of business. During the Quarter ended June 30, 2016, the Company incurred profits totaling \$673,777 resulting in total accumulated deficit of \$2,856,967 with a Total Shareholders' deficit of (\$5,050,798) at June 30, 2016. The past four quarters have shown net gains and increased assets continuing to show the Company's ability to continue as a going concern. The Company's ability to meet its ongoing financial requirements is not dependent on management being able to obtain additional equity and/or debt financing.

I. ROYALTIES

The Company has entered into several licensing agreements whereby the Company licenses content with a minimum guaranteed royalty. The Company is responsible for paying royalties to the content owners based on video rentals.
