

**1. Name Change**

At the Annual General Meeting of Shareholders held in Warsaw Poland on July 12, 2016, Shareholders approved the change of the Company's name to ARGUS WORLDWIDE CORP. The new name was officially registered with the State of Wyoming on August 30<sup>th</sup>, 2016.
