DIRECTOR/PDMR SHAREHOLDING

Britvic plc ("the Company") was notified on 6 February 2017 that the following transactions have taken place in relation to the Britvic Share Incentive Plan ("SIP") on 3 February 2017. The SIP is an all-employee trust arrangement approved by HM Revenue and Customs, under which employees are able to buy ordinary shares in the Company of 20 pence each ("Ordinary Shares"), using deductions from salary in each 4-week pay period, and receive allocations of matching free Ordinary Shares ("Matching Shares").

1. The SIP trustees have allocated 9,830 ordinary shares of 20 pence each to employees participating in the SIP as Matching Shares. These shares were allotted to the SIP on 3 February 2017 at nominal value (£1,966).
2.
