This is to confirm the following:

TPT Global Tech, Inc. (the Company or OTC:TPTW) has not been a shell company per definition in Item 1101 (b) of Regulation AB (229.1101(b)) since its reverse merger in late 2014 and acquisition of Copperhead Digital Holdings, LLC in January of 2015.

The status of the Company should have been changed at the latest in 2015 from a shell company.

The company has significant operating activities and assets in several different subsidiaries. The consolidated operating activities include \$2-3 million in revenues for each of 2016 and 2017 and \$8.8 million in assets, \$2.8 million in fixed assets as of December 31, 2017.
