Reason for Delay in Posting Financial Report: State below in reasonable detail why the Annual/Quarterly Report could not be filed within the prescribed time period.

In light of recent audit requirements imposed by MNP, LLP that include additional sample and test items, plus a requirement to complete a third-part independent purchase price accounting (PPA) analysis on the Sun Valley clinics acquisition, realistically we don't have enough time to complete these additional audit requests. The extensive nature of such an exercise is time prohibitive and resource intense, making it impossible to complete the MNP audit by June 15, 2020.

COVID-19 has exacerbated the resource challenges we are facing with our 2019 Audit. As a small cap Issuer we simply don't have the resources available to hire additional technical staff to cover the workload. Further, we face unique challenges imposed by the travel bans that have forced us to rely on local clinic administrative team members in different regions to support the technical audit work. These resources do not have full technical audit experience and we are required to provide training plus additional senior management oversight which is slowing down all aspects of the audit.
