

FACTS:

- The rejection letter package was sent out from Health Canada on Friday February 13, 2015 at 5:17 PM via Purolator <https://www.purolator.com/en/home.page> unbeknownst to Cen Biotech, Inc.
- Grant Robertson knew of the rejection letter and sent an email to the company (Bill Chaaban) on February 13, 2015 at 7:06 PM 5 days before the company received any information from Health Canada.
- On February 13, 2015 at 8:18 p.m. Bill Chaaban asks Robertson who would have sent the communication, since he never received any such communication.
- On February 13, 2015 at 8:48 Robertson apparently has inside information about a “letter” that CEN Biotech has not yet received.
- On February 13, 2015 at 10:27 p.m. Robertson ***knows*** that “there is a written communication that has been sent to you”, and Robertson states he knows this because he was “told”. The problem is that Robertson was ***told*** before CEN Biotech even received the letter (5 days later).
- An article was published on Saturday February 14, 2015 at 6:00 AM written by Grant Robertson.
- The Package was received February 18, 2015 at 10:24 AM to the personal address of Mr. Chaaban and not to the address on the application for CEN Biotech, Inc.

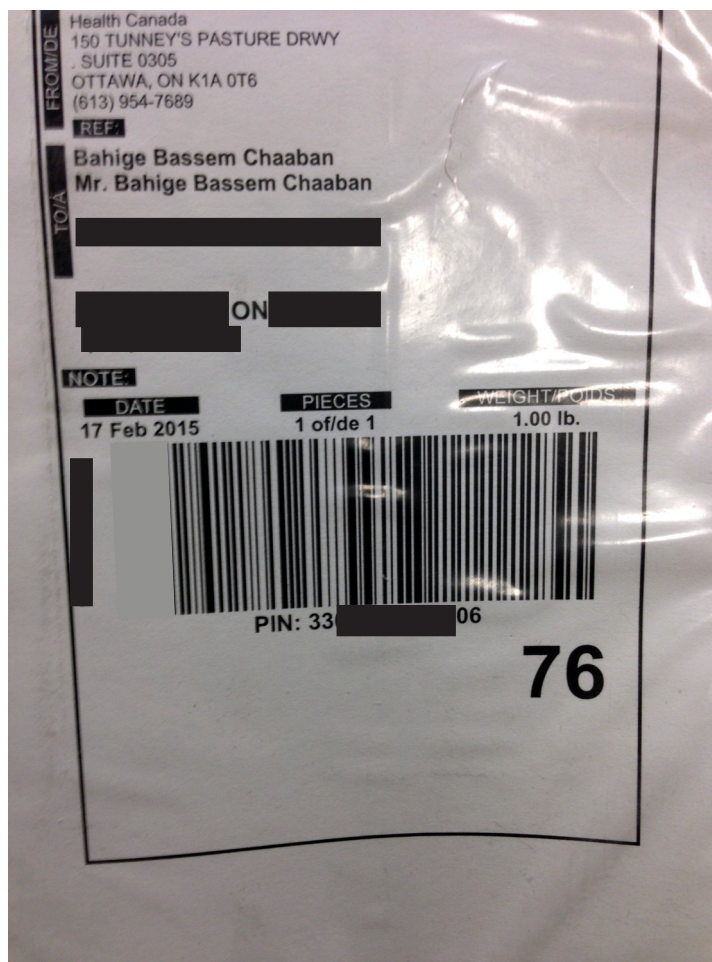
