We are writing to you regarding a recent article in Forbes in which it states "In November the company was notified by Canada's federal health department, Health Canada, that it has been approved to grow, distribute, import and export medicinal marijuana and plant seeds through its Canadian subsidiary CEN Biotech."

We wish to remind you that the letter dated November 26, 2013, sent to you regarding your licence application for CEN Biotech is not a guarantee that a licence will be issued, and that this letter does not constitute approval to possess, produce, distribute, export, import, or conduct any other activities with cannabis.

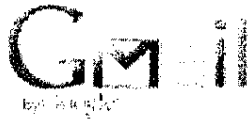

Dear Applicant,

We would like to inform you that your application (10-MM0118) is at the personnel security checks stage. Note that until such a time as we receive the results from your security checks, there will be no further communications with the applicant.

Information submitted to Health Canada is disclosed to the Royal Canadian Mounted Police for the purpose of conducting a security check. The Royal Canadian Mounted Police is working with local police detachment to obtain all relevant information to conduct the required verifications as per stated in section 91 of the MMPR.

As per section 91 of the MMPR on receipt of a fully completed application for a security clearance, the Minister must conduct the following checks for the purpose of assessing whether an applicant poses a risk to the integrity of the control of the production and distribution of cannabis under the Controlled Drugs and Substances Act and its regulations, including the risk of cannabis being diverted to an illicit market or use:

- (a) a criminal record check in respect of the applicant; and*
- (b) a check of the relevant files of law enforcement agencies, including intelligence gathered for law enforcement purposes.*

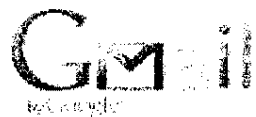
The time required to conduct these security checks varies with each application and you can expect that it will take a few months. Health Canada and the RCMP will not be able to provide you with updates.

A change in key personnel must be signalled as early as possible to minimise further delays. A change of site will require that you resubmit a new application.

Note that a pre-licensing inspection can only be conducted at the proposed site only once you have obtained all the required security clearances, that you have demonstrate within your application that you will comply with all the provisions of the MMPR and that you confirm that all of the security measures described in your application are installed, functional and comply with Division 3 of the MMPR.

Pursuant to our request for a meeting in Ottawa, you requested questions in advance for a phone conference. I apologize for the delay in submission. I present you the following:
We understand the sensitivities surrounding the MMRP and the pressures on the staff of Health Canada. We also present ourselves as your future partner in this new endeavor. We understand our actions, as individuals and a corporation may reflect on Health Canada. It is important to clarify that our company, and its officers and executive take the utmost pride in this project. It is our desire to make Canada, and Health Canada the world leaders in medicinal marijuana. We

believe the addition of world class physicians, and bankers to our parent company's board of directors will make us the beacon in the industry. We intend to conduct extensive research and development in the use of medical cannabis in conjunction with the University of Windsor. We have pledged half of our future intellectual property ownership to the University of Windsor for their joint cooperation. We intend to create a legacy for the community at large.

1. Security: CEN Biotech Inc. is a publicly traded company, and as such acts in the best interests of its shareholders. It is also a good corporate citizen and brings many much needed jobs to the Town of Lakeshore. This project is much larger than one individual. We understand there is a delay because of security. In our conversation with Todd Cain, we advised Health Canada that if one individual posed a problem for the project they would step down. Please advise if there is an issue with Bahige Chaaban or Donald Strlichuck (or anyone within their circle or family); if so, one or both would be immediately replaced.

2. Corporate structure : I, Bahige Chaaban, the intended RPIC and applicant, am the President & CEO of Creative Edge Nutrition, and the President & CEO and sole director of CEN Biotech Inc. Furthermore, I have super voting rights (5000:1) in my preferred shares which gives me a majority vote over the common shares. There is no possibility of me losing control of our company to any individual or organization. To further our commitment to Canada and Canadian content, we have decided to move to the Toronto Stock exchange and move all of our corporate offices to Canada. We will no longer be a US company. Does our US lineage affect our ability to obtain a license?

3. Inspections: We now have two sites ready for pre-license inspection. We have 10-mm0118 and 10-mm0481. (Site 1 and Site 2). Site 2 was built to be a joint research and development facility with the University of Medical School. We intend to conduct clinical trials with medical cannabis for treatment modalities for various disease states. Site 2 will be instrumental to the future of medical cannabis in Canada and the World. Both sites will follow Health Canada's guidelines as pronounced under the MMPR. All product will be shipped from site 1, our intended maximum security super grow facility with a 4000 square foot vault. This site has _____ worth of security measures.
