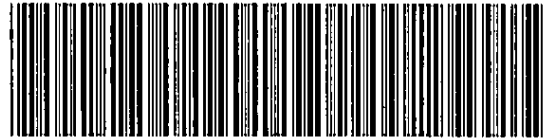

ARTICLE IV. CAPITAL STOCK

Formerly, the article stated:

The Corporation is authorized to issue two classes of shares to be designated, respectively, "Preferred Stock" and "Common Stock". The number of shares of Common Stock authorized to be issued is Five Billion (5,000,000,000). The number of shares of Preferred Stock authorized is Two million Five Hundred Thousand (2,500,000). The Preferred Stock and Common Stock shall each have a par value of \$0.0001 per share.

The remaining subsections of Article IV remain unchanged in their entirety.
