ORDER ON PLAINTIFF'S MOTION FOR TEMPORARY INJUNCTION

THIS CAUSE came before the Court for hearing on October 11, 2016, on Plaintiff's Motion for Temporary Injunction. The Court, having reviewed its file, and having heard the argument of counsel, and being otherwise fully advised in this matter, it is hereby:

ORDERED AND ADJUDGED that the Motion is GRANTED IN-PART as follows:

- 1.** Plaintiff, HOLLYWALL ENTERTAINMENT, INC., shall pay a cash bond of \$10,000.00 to the Trust Account of the Defendant's Counsel, Bryan J. Yarnell, PLLC.
- 2.** Plaintiff, HOLLYWALL ENTERTAINMENT, INC., shall furnish a \$29,100.00 bond to the Court.
- 3.** For the reasons stated on the record, this Order shall immediately serve as an injunction upon the payment of a \$10,000.00 cash bond and the posting of a \$29,100.00 bond.
- 4.** Thus, upon Plaintiff's payment of the \$10,000 cash bond and Plaintiff's posting of the \$29,100 bond with the Court, Defendant CLEARTRUST, LLC shall at that time become enjoined by this order and from that time it shall not issue any shares of Plaintiff HOLLYWALL

ENTERTAINMENT, INC Entertainment's stock converted by Defendant BLACKRIDGE CAPITAL LLC until such time as the injunction created by this order and the payment of the bonds expires in 14 days.

5. The injunction that may be created by payment of the bonds shall expire fourteen (14) days from the date this Order is entered.

6. Plaintiff, HOLLYWALL ENTERTAINMENT, INC. shall establish jurisdiction with the Court within fourteen (14) days from the date this Order is entered.
