- A. Business Development.
- a. In January 2002, the Company then-known as "Buoy Club, Inc." acquired Identa Ltd. an Israeli Company in a reverse acquisition resulting in a change of control.
- b. The fiscal year end date for the company is December 31.
- c. The Company has not and is not in the process of filing bankruptcy, receivership or any similar proceedings.
- d. The Company has not made any material reclassifications, mergers (since January 2002), consolidations, or purchases or sales of any significant amount of assets.
- e. The Company is not in default of the terms of any note, loan, lease, or other indebtedness or financing arrangement requiring the issuer to make payments;
- f. The Company has not had any change of control since January, 2002.
- g. The company has had in the last year an increase of 10% or more of the same class of outstanding equity securities;
- h. The Company's securities have not been de-listed and are not in the process of being de-listed by the Securities and Exchange Commission or NASDAQ.
- i. There are no current, past, pending, or threatening legal proceedings or administrative actions.

B. Business of Issuer.

The Company develops and manufactures advanced forensics products primarily, designed for law enforcement agencies around the world.

In addition, the Company develops and manufactures forensics products – drug detectors- for the wider drug detection "retail" market such as schools, corporations, security companies, worried - parents, drug store chains, etc.

Identa Corp is the only company selling drug detectors (chemical reaction) in the retail market, due to the most advanced detector.

The Company's products are based on the more than 30 years of experience of its Chief Scientist, Baruch Glattstein, who is a former chief scientist of the Israeli Police forensic department.

- 1. The Company has developed and manufactures a novel and unique drug detector field test kit known as "DDFK". DDFK is a chemical device, for identification instantly of different kinds of illicit drugs in the field including: Marijuana/hashish, Cocaine/Crack, Brown and White Heroin, Ecstasy-MDMA, MDA, Amphetamine and Methamphetamine (Crystal meth), LSD, Morphine, Ketamine, GHB, Bath salt, **Synthetic Cannabinoids** etc. Actually Identa has drug detectors for any known illicit drugs. Today Identa Corp is able to provide DDFK, for any known illicit drug (in the literature) and capable to develop a new kind of detector for any new illicit drug.
- 2. In the last years Mr. Baruch Glattstein has developed a new and unique **General Drug Screening Kit**, a kit with advanced chemistry, able to give a positive response for 21 types of known drugs. An immediate answer (instant) for the most important question: is the suspected substance an illicit drug or not! In one simple test, breaking only up to two ampoules and receiving a most reliable response for almost all known illicit drugs, (except marijuana/ hashish, because they are from plants).

The Company's different products have several advantages over competitive products, including:

- a. Our drug detector kits are one or double step process. If the kits are double step (using two units- two different plastics) than the process is:
 - Step 1- detection step (step still containing false positives)
 - Step 2 confirmation step (on a laboratory level on the field), step separation between the false positives substances (still

received in the first step, the detection step) and the illicit drug.

b. The Identa's detectors have no false positives. As far as the Company is aware, our products are the only ones in the market which the result has no false positives.

Those kits give a very fair answer for an acute problem faced by the different legal enforcement agencies around the world, to identify immediate on the field the suspected substance (powder, pill, etc).

- c. The new General Drug Screening Kit is a most advance device, to be used by the different law enforcement agencies, military groups and by the retail market (worried parents, working place and schools).
- d. All of Identa's drug detectors are "green" products, having build- in the kits a neutralization process for neutralizing the strong acid. The neutralization system is unique for Identa's kits.
- e. The kits are user friendly, using a patented durable plastic casing.
- f. Inexpensive.

3. Key product features of IDenta's explosive detectors include:

- a. The methodology provides a very safe testing method that will pose no danger at all to the user.
- b. Detectors are able to detect the full range of the well-known types of military, commercial and the homemade explosives including: TNT/PETN, RDX/Nitrate, Urea Nitrate, Ammonium Nitrate, TATP/HMTD and Chlorate/Bromate.
- c. IDenta's new TATP/HMTD detector has consistently tested showing No False-Positives.
- d. The detectors have at least 3 years period of chemical stability.
- e. Durable, easy to use, self-contained plastic packaging will enable the products to be used in a wide-variety of field operations including in the field military operations as well as civilian applications such as airport security.

- f. The products are also very competitively priced.
- g. High sensitivity to detect small amount.
- 4. Identa Corp. has also developed an additional forensic product, the BTK-Bullet Hole Test kit. The identification of bullet-holes and of marks produced by projectiles has been shown to be very crucial in the investigation of criminal cases involving the use of firearms. Such bullet-holes are usually characterized by the presence of metals (mainly lead and copper), originating from the bullet's outer surfaces, in the perimeters of these holes. The morphology of the hole alone at the scene of an investigation can often lead to erroneous conclusions, but by using IDenta BTK, a rapid and reliable identification of suspected bullet-holes in the field can be made.

This product is a unique product, owned and manufactured only by Identa Corp.

- 5. In the last years Mr. Baruch Glattstein has developed kits for Precursors. Identa Corp is manufacturing precursor kits for the following type of products: -for acetic anhydride, ephedrine/pseudoephedrine, ecstasy and methamphetamine.
- 6. Identa Corp has developed detectors for the new drug problem, the synthetic drug the designer drugs.
- 7. The last developed product is the Sniff and Know a handy sniffer for illicit drugs and explosives.

 A Fast Collection & Detection System for Suspected Particles on Surfaces Everywhere. The sniffer is working on substances (visible) and on traces (UNVISIBLE at nano gram level).

The sniffer is able to collect substances and traces from: Boxes, Cars, Table, Clothes, Containers, Rooms, Pallets etc. The Sniff and Know (sniffer) is compatible with Identa's illicit drugs and explosives test kits.

The Company does not have any parent, subsidiary, or affiliate.

The Company does not foresee any substantial changes in existing or probable governmental regulations that could adversely affect the business of the company at this time.

The Company has spent a great deal of time, investments, preparation and labor on the research and development of the company and it can only give a rough estimate on the amount of time and preparation spent on the development and research of the potential products of the company. At this point in time none of these costs have been passed on or are borne by the customers.

Identa has spend a lot of investments to create a new applicator, (the special stick for collecting the suspected substances). The current applicator is able to dip (in suspected powder) and to scrub (in suspected pills) in a 0,1 milligram (the smallest amount of substance needed for the chemical reaction).

The new applicator, is able to wipe down surfaces also, in addition to the dip and scrub process. The new applicator is efficient for nanogram. The new applicator is working on Invisible suspected substances. It is a major breakthrough for collecting suspected substances, especially for explosives.

- 6. The Company is in full compliance with all environmental laws in conjunction with its operating activities.
- 7. The Company has 13 employees.

C. Investment Policies.

At the present time, the company has investments. Going forward, all revenue not allocated for expenses are and will be invested into the business to generate additional revenue for the Company. There are no limitations with regard to the percentage of assets invested nor on the type of instruments used. Investment policy may only be changed by a vote of the Board of Directors.

Overview

Management's Discussion and Analysis of Financial Condition and Results of Operations.

Identa Corp has started the activity 13 years ago.

When the activity has started Identa Corp has only detectors for 3 kind of drug detectors (for cocaine/crack , heroin, marijuana/hashish).

Since then we have continued the r&d in the specific forensic area for detecting and identifying suspected substances.

- -Today Identa Corp has dozens of detectors for drug detectors. Actually we are the only company possessing detectors for any kind of illicit drug detectors known in the "industry"
- Identa corp has detectors to identify any known explosives.
- Identa corp has developed in the last years 5 detectors for precursors (illicit drugs)

- The additional product is unique for the company, the BTK Bullet Test Kit.
- -A Sniffer has been developed, based on Identa's different detector kits (illicit drugs, explosives, precursors).

Identa Corp has developed a line production with a plant in Jerusalem Israel.

As far as the company knows, Identa Corp is the unique company in this specific forensics area having a R&D department.

Identa Corp has developed in the last years a marketing and sale process for the different products.

The marketing and sale process is at developing stage. It has started about 4-5 years ago in a slowly page.

The process to introduce new forensics products to the legal law enforcement agencies in different markets and countries is a long process, due the request from any agency to test the products (in laboratory and in the field) before accepting them as products to be used in the field by the officers or any other agent.

Each agency has his own demands and regulation, therefore Identa has developed new products or adjusted the existing products to the demand from the different agencies.

The main development, as a result from such of demand is the General Drug Screening Kit, developed by the request from the Indian market.

The General Drug Screening Kit is able to identify in one simple test (by breaking only two ampoules) up to 21 different kind of illicit drugs.

Today we at Identa Corp believe that the conditions are "ripe" to accelerate the marketing and sales process in the current markets and especially in new markets.

The most important efforts we are investing in introducing the drug detectors kits in the retail-consumer (Drug store chains, educational institutes – especially in the high school system , working place) markets in the USA and in the many different Legal Law enforcement agencies around the world.

The Identa's products are on the shelf of the drug store chain, Wakgreens at 8700 stores.

This is a major development for the company, actually it is the most important event since the company has started the activity in USA. The retail-consumer success will be a major factor to penetrate finally the American legal law enforcement

also in a large scale.

In the same time we are continuing our efforts to introduce our different products in many countries, especially in new markets like, China, Russia, UK., Brazil, Mexico
