Reference is herein made to Maverick Technology Solutions ticker symbol OTC: MVRK which as of today is designated as a shell.

We herein notify you that due to the company's ongoing business activities, Maverick Technology Solutions qualifies as a Non-Shell company as defined by the SEC guidelines.

We are pursuing our business endeavors as referenced in several press releases and filings as an active and operating enterprise engaged in the efforts of designing, manufacturing and selling our patent pending heat press extraction products and technology world-wide.

We have developed a best of breed technology and product line including the Rosinbomb Rocket (MSRP \$599.00 U.S.) and the Rosinbomb M-50 (MSRP \$1850.00 U.S.). We have established reseller relationships and strategic partnerships for our products through major distributors and resellers including but not limited to; Namaste (UK), Focus Camera and Hawthorne Gardening (a division of Scott's Miracle Gro). In addition, the company's products are now available on Walmart.com https://www.walmart.com/search/?cat_id=0&query=Rosinbomb The company has an installed base of over 3000 customers.

As reported in our recently filed year end financials (fiscal year ending September 30th, 2018) the company achieved 2018 revenue of 524K. In addition, our quarterly Q1 2019 revenue (ending December 30th, 2018) was 142,725 with a gross profit of 64K and growth of 26.5 percent over Q1 2018

In addition, we have two patents pending with the U.S. Patent Office. Design Patent number 29602909 was filed on May 14th, 2017, for the Rosinbomb M-50 electric heat press and Design Patent filing number 16/190,124, was filed on November 13, 2018. The company's products and technology have been reviewed and featured in mainstream media outlets including Forbes and Engadget as well as many industry specific media sources.

The company keeps 30 days of inventory of parts, components, finished and unfinished goods on hand at any one time. In addition, the company owns a number of manufacturing assets and equipment necessary to execute on its manufacturing and production needs. Those assets include but are not limited to: Bridgeport 2 Axis Manual Mill, Central Machinery Combo sander(61750), Central machinery Metal cutting bandsaw (97009), Central machinery floor drill press (38142), Central machinery 8" grinder (36127), Central machinery 32 inch sheet metal brake, Miller 35 welder (HJ139860), Husky 26 Gallon air compressor (vt631502aj), Hitachi 10" compound miter saw(c1808176), Chicago 4" angle grinder(91222), Workforce pro printer (wf-4630), Hp Laptop (15t-bs000), Acer laptop (n16q2), MacBook Air laptop (a1466) and AutoCAD Design Software.
