NOTES TO UNAUDITED CONSOLIDATED FINANCIAL STATEMENTS

For The Period Ended June 30, 2020

NOTE 1: THE COMPANY AND THE SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of these financial statements:

<u>Organizational Information</u>: Orion Diversified Holding Co, Inc. (the Company) was incorporated in 2008 in the State of Nevada.

<u>Industry Information:</u> The Company owns land in the Ten Mile Gold Mining District of Nevada and is developing producing oil and gas properties in the Permian Basin of West Texas.

Basis of Presentation: The accounting records of the Company are maintained on the accrual basis and the accompanying financial statements are presented on the accrual basis.

<u>Principles of Consolidation:</u> The accompanying consolidated financial statements include the accounts of the Company. Inter-company transactions and balances have been eliminated.

<u>Depreciation and Amortization:</u> The cost of property and equipment is depreciated over the estimated useful lives of the related assets using the accelerated recovery periods of the Internal Revenue Service. Purchased software is amortized on the straight-line basis over five years; organization expense and trademarks are amortized on the straight-line method over sixty months.

<u>Accounts Receivable:</u> The accounts receivable arise in the normal course of business of providing services to Customers. Accounts are written-off as they are deemed uncollectible based upon a periodic review of the accounts. At this time the company has no receivables.

<u>Concentration of Credit Risk:</u> Financial instruments that potentially subject the Company to concentrations of credit risk consist principally of bank deposits and trade accounts receivable. The Company has concentrated its credit risk for cash by maintaining deposits in financial institutions within the geographic region of Midland, Texas, which may at times

exceed amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation (FDIC). There is no excess deposit liabilities at this time. The Company has not experienced any losses in such accounts and believes it is not

exposed to any significant credit risk to cash.

Management Estimations: The preparation of financial statements in conformity with generally accepted accounting

principles requires management to make estimates and assumptions that affect the reported amounts of assets and

liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported
