Osceola Gold Inc. f/k/a PhyHealth, is the holder of that certain (ALL MAV Claims) claim grouping in the Osceola Mining District located in White Pine County (Baker), Nevada, which district has previously, been successfully mined since the district's founding, circa 1872. The primary minerals that have been excavated in the Osceola Mining District have been gold and tungsten. The Osceola Mining District remains rich in gold and trace minerals. The claims immediately adjacent to Osceola Gold's claim are currently operated by North America's largest mining companies; among them, Barrick and Kennecott.

Having now paid the bond, the Company intends to commence mining its claim following the requisite notifications to the Bureau of Land Management, and will be mining its claim using traditional, non-chemical processes. The Company will be mining the MAV 5 G gold claim in accordance with a lease with Pizz Inc. The Company, in conjunction with its lease arrangement with Pizz Inc., possesses the option to acquire adjacent claims, following its initial development and excavation of its current proven claim.

All the senior executive management of Pizz Inc. and the Company are experienced in mining and activities and corporate management.
