The two companies concluded that sufficient synergy of interest exists in the search for new renewable energy projects and marketing to make a more solidly structured business combination.

The Merger accomplished the following:

- Renewable Energy Solution Systems, Inc. of Nevada distributed 100% ownership of Jackie Beeson Working Interest, Inc., by means of a stock dividend to existing shareholders, share for share. WORCO and Associates, who have interests in Jackie Beeson, surrendered three hundred million (300,000,000) shares of the Nevada corporation to treasury for cancellation.
- Each and every share of Renewable Energy Solution Systems, Inc. of Florida (one hundred seven million, nine hundred and two thousand four hundred – 107,902,400) was converted into one share of the Nevada Corporation after cancellation of the 300,000,000.

As a result of the Acquisition, Renewable Energy Solutions Systems, Inc. will have 169,952,774 shares of common stock outstanding. The Acquisition has not affected control of the Company.
