B. Legal/Disciplinary History

Texas Hill Country Barbecue, Inc., and Jerry Monday and Gary Bryant, both shareholders in Texas Hill Country Barbecue, Inc. (herein referred to as the Plaintiffs), filed a lawsuit against Jason Ford, Susan Ford, Jay Ford and Bootleg Barbecue LLC, a Texas Limited Liability Corporation (collectively referred to as the "Defendants"), and received a judgment against the Fords.

The lawsuit alleged that:

1. The Defendants removed approximately \$400,000 from the Company's bank accounts without any legitimate business justification.
2. The Defendants removed and took sole possession of an antique fire truck and a barbecue smoker that have a replacement value of \$27,500.
3. The Defendants have no authority to act on behalf of THCB in any capacity whatsoever.
4. The Defendants issued the following stock on an unauthorized basis:
 - a. Jason Ford – 1,500,000 shares
 - b. Susan Ford – 500,000 shares
 - c. Rachel Ford - 1,400,000 shares

On July 20, 2012, the Second Judicial District Court in the State of Nevada issued a Default Judgment against the Defendants. The Court also entered a Declaratory Judgment declaring that:

1. On March 16, 2011 all Defendants who were then Directors and/or Officers of THCB, specifically including, Defendants Jason Ford and Susan Ford, and all other directors and officers of THCB (which included Arvind Sharma, R.D. Franklin, Fred Wills, Ty Gerot, Jay Novacek and Mark Ussery), were lawfully removed and the present directors, as set forth in the official records of the Nevada Secretary of State, including Plaintiff Jerry Monday, were elected to office by majority shareholder consent resolution.
2. None of the Defendants are officers, directors or hold any other position of management or control, or have any other position whatsoever in or with Plaintiff, Texas Hill Country Barbecue, Inc.
3. None of the Defendants are authorized or have any standing to continue to prosecute the litigation filed and still pending in the District Court of State of Texas, Tarrant County, 236th Judicial District, Cause No. 236-249797-10, styled "Texas Hill Country Barbecue, Inc. vs. Vega, et al.".
4. The following shares of THCB common stock were not properly issued, THCB did not receive any consideration for them, and they are cancelled and considered null and void:
 - a. Jason Ford - 1,500,000 shares
 - b. Susan Ford - 500,000 shares
 - c. Rachel Ford - 1,400,000 shares

The Court also awarded damages to the Plaintiff in the amount of \$559,000. The Company has not yet collected the damages. On September 14, 2012 the Court held Jason Ford in contempt of court.

In addition, Jason Ford filed a lawsuit in the name of Texas Hill Country Barbecue in State District Court in Tarrant County (referred to in paragraph 3 above) against the new board of directors and others, a suit which the final order in the Nevada Court determined was commenced without authority. That lawsuit has been abated by the Tarrant County Judge Presiding.
