



## Notice-and-Access

The Canadian securities regulators have adopted new rules, effective for meetings held on or after March 1, 2013, which permit the use of notice-and-access for proxy solicitation instead of the traditional physical delivery of material. This process provides the option to post meeting-related materials including management information circulars, as well as annual financial statements, management's discussion and analysis, on a website in addition to SEDAR. Under notice-and-access, meeting-related materials will be available for viewing for up to one year from the date of posting and a paper copy of the material can be requested at any time during this period.
