**CURRENT UPDATE**

On May 3, 2013, Issuer became aware of past current information disclosures published via OTCMarkets.com that Issuer believes contains the same factual misstatement. Namely, the two following disclosures contain statements that Issuer has previously been a “Shell” company, as defined by SEC Rule 144(i)(1):

- Interim Financial report for the three months ending March 31, 2011  
(published on June 2, 2011)

- Initial Company and Disclosure Statement (published February 24, 2010).

The Company has undertaken a review of these filings and believes that they were made in error, as none of the circumstances or characteristics that give rise to Shell Company status appear to be applicable to the Issuer. Prior and subsequent to both disclosures, Issuer disclosed itself not to have been a Shell Company. The Company is unable to determine the reason for the statements made in the two disclosures, in light of the time that has passed, as well as changes in the interim changes in Issuer's control, operations and accountants/auditors. Issuer promptly will take any and all action to correct the disclosures.
