We suggest overnight courier, or if by mail, registered mail, properly insured with return receipt.
- Please write the numbers of WNTR common shares you own in Box B.
- Please indicate the total number of WNTR common shares you are tendering in Box C.
- Indication of Price at which WNTR are being Tendered. If you want to tender your WNTR you must properly complete the pricing section of this Letter of Transmittal, which is called "WNTR Tendered At A Price Determined By You". You must check one box in the pricing section. If more than one box is checked or no box is checked, your WNTR will not be properly tendered. If you want to tender different portions of your WNTR at different prices, you must complete a separate Letter of Transmittal for each portion of WNTR being tendered at different prices. It should be noted that the same WNTR cannot be tendered at more than one price. NOTE: No withdrawals permitted.
