Item 1: Names of the Parties to the Transaction

Greenflag Ventures Inc. ("**Greenflag**")

Item 2: Description of the Transaction

Greenflag completed a reorganization under the *Business Corporations Act* (British Columbia) with American First Financial Inc. ("**American First**"), a private British Columbia company, pursuant to a reorganization agreement dated July 27, 2015 whereby American First acquired 60% of the issued and outstanding common shares of Greenflag in exchange for 100% of the issued and outstanding common shares of American First, as approved by the board of directors of Greenflag on July 27, 2015 (the "**Reverse Merger**").

Prior to the reorganization of Greenflag, American First completed a reorganization with WTTJ, Corp., a corporation incorporated under the laws of the State of Michigan ("**WTTJ**") pursuant to a reorganization agreement dated July 1, 2015 whereby WTTJ acquired 100% of the issued and outstanding common shares of American First in exchange for 82% of the issued and outstanding common shares of WTTJ.

Item 3: Effective Date of the Transaction

July 27, 2015.

Item 4: Names of each party, if any, that ceased to be a reporting issuer subsequent to the transaction and name of the continuing entities

No party ceased to be a reporting issuer subsequent to the completion of the Reverse Merger.

Upon completion of the Reverse Merger, the Company continued to be a reporting issuer in the provinces of British Columbia and Alberta.
