

# CYBER ATTACK

## *Former Consultant Hijacks URLs and Company Emails*

### **New Website and Email Addresses, Important DSUS Shareholder Update**

FENTON, MI, October 21, 2015 - Drone Services USA, Inc., (OTC Markets: DSUS), (the “Company”), has formally terminated its relationship with one of its consultants and all known associates. The moment we have secured this attack on our cyber identity, we will notify you immediately through an updated press release and will look to update our information on [www.otcmarkets.com](http://www.otcmarkets.com) at that time. Until then we ask you for your patience and understanding. We are working through these issues and cannot wait to get back to what we do, without the drama. The Company, management, and its board members believe in transparency with the market and its shareholders.
