Desktop Publishing Glossary

An image in which the subject has continuous shades of color or grey without being broken up by dots. Continuous tones cannot be reproduced in that form for printing but must be screened to translate the image into dots.

Digital Camera Dictionary

An image where brightness appears consistent and uninterrupted. Each pixel in a continuous tone image file uses at least one byte each for its red, green, and blue values. This permits 256 density levels per color or more than 16 million mixture colors.


AVATAR believes this to be a very significant first providing opportunities for artists, musicians, photographers, tourism and for people who wish to have quality keepsakes.
