On March 23rd, 2022, Technomeca Defense, Inc, a Co., a Company that is controlled by Mr. Rafael A Pinedo was elected and consented to serve as the sole officer and director of the company and Frank I Igwealor and Ambrose Egbuonu, the previous officers and directors resigned from all positions.

- iii. A change in the composition of the Board occurring within a two (2)-year period, as a result of which fewer than a majority of the directors are directors immediately prior to such change; or
- iv. The consummation of a merger or consolidation of the Company with any other corporation, other than a merger or consolidation which would result in the voting securities of the Company outstanding immediately prior thereto continuing to represent (either by remaining outstanding or by being converted into voting securities of the surviving entity or its parent) at least fifty percent (50%) of the total voting power represented by the voting securities of the Company or such surviving entity or its parent outstanding immediately after such merger or consolidation.
