In 2022, the company appointed Galen Reich as President of PRRY. Galen served as General Manager and Marketing Manager for Recreatives Industries from 1993 to 2013 when the company was first sold and has since served in upper management with all subsequent owners of the MAX ATV brand.

PRRY will capitalize on MAX's brand legacy of 53 years by focusing on building the MAX ATV product line from existing, proven designs, which will ensure a rapid re-entry into the broader global ATV market which continues to grow at over 1,000,000 units per year. Beyond traditional MAX ATV production, PRRY plans to diversify its product line by introducing new vehicles and products to market in a compressed timeframe. The company's planned diversification includes larger eight-wheeled vehicles (8x8) as well as electric vehicle (EV) drivetrains to draw on recent advancements in battery and drive motor technology, which make fitment in smaller vehicles possible. PRRY management believes that electric vehicles can offer performance that exceeds that of the traditional mechanical transmissions that most all-terrain vehicles employ.
