We are authorized to issue unlimited shares of common stock, with a par value of \$0.001. All shares of common stock have one vote per share on all matters including election of directors, without provision for cumulative voting. The common stock is not redeemable and has no conversion or preemptive rights. In the event of liquidation of the Company, the holders of common stock will share equally in any balance of the Company's assets available for distribution to them after satisfaction of creditors and preferred shareholders, if any. The holders of the Company's common are entitled to equal dividends and distributions per share with respect to the common stock when, as and if, declared by the Board of Directors from funds legally available.

For preferred stock, describe the dividend, voting, conversion, and liquidation rights as well as redemption or sinking fund provisions.

Series A Preferred Stock. Our Series A Preferred Stock rank is subordinate to all shares of common stock and do not have voting rights. The Series A Preferred Stock has a stated value of \$5 per share. The Series A Preferred Stock is entitled to receive dividends of 10% of the net profit of VIVIS Corporation. The holders of the Series A Preferred Stock have the option to convert each share into 800 shares of common stock of the Company.

Series B Preferred Stock. Our Series B Preferred Stock rank is subordinate to all shares of common stock and do not have voting rights. The Series B Preferred Stock has a stated value of \$5 per share. The Series B Preferred Stock is entitled to receive dividends of 0.4% of the net profit of VIVIS Corporation. Holders of the Series B Preferred Stock have the option to convert each share into 800 shares of common stock.

Series C Preferred Stock. Our Series C Preferred Stock rank is subordinate to all shares of common stock and do not have voting rights. The Series C Preferred Stock has a stated value of \$5 per share. The Series C Preferred Stock is entitled to receive dividends of 10% of the net profit of VIVIS Corporation. After the Series C Preferred Stock has received cumulative dividends of \$500,000, the dividend rate will reduce to 1%. Holders of the Series C Preferred Stock have the option to convert each share into 38 shares of common stock.

Series E preferred stock The Series E Preferred Stock is subordinated to our common stock. It does not receive dividends and does not participate in equity distributions. The Series E Preferred stock has 2 votes for each outstanding share of common stock in the company.

Series F preferred stock The Series F Preferred Stock is subordinated to our common stock and superior to all shares of Preferred Stock. It does not receive dividends and does not participate in equity distributions. The Series F Preferred stock retains 2/3 of the voting rights in the company.

Series G convertible preferred stock. The Series G convertible preferred stock has a stated value of \$1.00 per share, carries no voting rights and earns dividends of 8% per annum on the stated value of the stock. The Series G convertible preferred stock is redeemable at the option of the Company during the first nine months it is outstanding at a premium of between 3% and 33% depending on the date of redemption. After the stock has been outstanding for nine months, it is convertible into common stock of the Company at a 29% discount to the market value of the common stock.

VIVIS Corp. manufactures all of its own products including inhalable products, transdermal products, and ingestible products that are made with hemp-based cannabinoids. The hemp-based cannabinoids include but aren't limited to cannabidiol (CBD), Cannabinol (CBN), Cannabigerol (CBG), Cannabichromene (CBC) and other alternative cannabinoids. VIVIS manufactures white-label products for other retailers as well as selling its own VIVIS branded products through some wholesale and its own e-commerce website, www.viviscorp.com.

Neutra Corp's second wholly owned subsidiary, Neutra Life Sciences is a Clinical Research Site Management Organization. As a Clinical Research SMO, it is comprised of multiple clinical research sites with multiple specialties. This includes but aren't limited to, Pediatrics, Pediatric Pulmonology, Urgent Care, Family Medicine, Optometry, Podiatry and Oncology. At these clinical research sites, NLS conducts industry sponsored clinical trials that help provide the data to the industry sponsors to apply for FDA approval.

NOTES TO THE UNAUDITED CONSOLIDATED FINANCIAL STATEMENTS
April 30, 2025

Note 1. Background Information

Neutra Corp. was incorporated in Nevada on January 11, 2011, to market and participate in the nutraceutical space by bringing products derived from all natural and organic origins. Along with participating in the actual nutraceutical products, we plan to research and bring new technology to the nutraceutical space. Nutraceutical natural medicine is an alternative system that focuses on natural remedies and the body's vital ability to heal and maintain itself. One of the nutraceutical sub-markets is the new thriving medical cannabis market, in which we intend to participate. We intend to entrust the manufacturing to a nutraceutical contractor to private label all of our products and to sell them under our unique brand. We have established a fiscal year end of January 31.

As the global cannabis market grows exponentially, it is constantly in need of better technologies and products to be more efficient in how it grows, what it grows and how it consumes cannabis and its related products. From lighting to dosage devices, from pesticide replacements to plant enhancers, Neutra Corp. is constantly combing the industry for the latest and greatest to test, prove and bring to market.

On February 18, 2025, the Company entered into a securities purchase agreement with Neutra Life Sciences, LLC ("NLS"), a Texas limited liability corporation, which was controlled 100% by Sydney Jim, the Company's Chairman and CEO. Pursuant to the terms of the agreement, the Company acquired 1,000,000 shares, representing 100% of the outstanding equity securities of Neutra Life Sciences, for \$900,000 payable in 180,000 shares of a convertible preferred stock that has not yet been designated. The convertible preferred stock will be convertible into common shares at a ratio of one share of preferred stock for 50 common shares. As NLS was controlled by the controlling shareholder of the Company, the transaction was considered a combination of entities under common control under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 805, with assets and liabilities of NLS being recognized on the Company's balance sheet at carryover basis in accordance with ASC 805. The results of operations and cash flows of NLS are included in the Company's consolidated financial statements since the incorporation date of NLS.

NLS began operations in August 2024. Neutra Life Sciences principal services are clinical research services include full turn-key research conducting services such as: Study Start-up, IRB Submission, Contracts & Budgets negotiations, Clinical Research Staff, Clinica Study Inventory and management, Regulatory Services, Patient Recruitment and other clinical research services.

Note 2. Going Concern

For the three months ended April 30, 2025, the Company had a net loss of \$973,076. As of April 30, 2025, the Company has negative working capital of \$1,182,410. We have generated limited revenues to date and our activities have been primarily limited to developing our business plan and research and development of products. We will not have the necessary capital to fully develop or execute our business plan until we are able to secure additional financing. There can be no assurance that such financing will be available on suitable terms. We need to raise additional funds in order to implement our business plan. Our current cash on hand is insufficient to commercialize our products or fully develop our business strategy. If we are unable to raise adequate additional funds or if those funds are not available on terms that are acceptable to us, we will not be able to execute our business plan and we may cease operations.

These factors raise a substantial doubt about the Company's ability to continue as a going concern. The accompanying financial statements do not include any adjustments to reflect the possible future effects on the recoverability and classification of assets or the amounts and classifications of liabilities that may result from the possible inability of the Company to continue as a going concern.

The Company does not have the resources at this time to repay its credit and debt obligations, make any payments in the form of dividends to its shareholders or fully implement its business plan. Without additional capital, the Company will not be able to remain in business.

Management has plans to address the Company's financial situation as follows:

In the near term, management plans to continue to focus on raising the funds necessary to implement the Company's business plan. Management will continue to seek out debt financing to obtain the capital required to meet the Company's financial obligations. There is no assurance, however, that lenders will continue to advance capital to the Company or that the new business operations will be profitable. The possibility of failure in obtaining additional funding and the potential inability to achieve profitability raises doubts about the Company's ability to continue as a going concern.

In the long term, management believes that the Company's projects and initiatives will be successful and will provide cash flow to the Company that will be used to finance the Company's future growth. However, there can be no assurances that the Company's planned activities will be successful, or that the Company will ultimately attain profitability. The Company's long-term viability depends on its ability to obtain adequate sources of debt or equity funding to meet current commitments and fund the continuation of its business operations, and the ability of the Company to achieve adequate profitability and cash flows from operations to sustain its operations.

Note 3. Significant Accounting Policies

The significant accounting policies that the Company follows are:

Interim Financial Statements

The accompanying unaudited financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP") for interim financial information and with the instructions to Form 10-Q and Regulation S-X. Accordingly, the consolidated financial statements do not include all of the information and footnotes required by GAAP for complete financial statements. In the opinion of management, all adjustments considered necessary for a fair presentation have been included and such adjustments are of a normal recurring nature. These consolidated financial statements should be read in conjunction with the consolidated financial statements for the fiscal year ended January 31, 2025 and notes thereto and other pertinent information contained in our annual report.

The results of operations for the three month period ended April 30, 2025 are not necessarily indicative of the results to be expected for the full fiscal year ending January 31, 2026.

Basis of Presentation

The unaudited consolidated financial statements and related disclosures have been prepared pursuant to the rules and regulations of the SEC. The unaudited consolidated financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Consolidated Financial Statements

The unaudited consolidated financial statements of the Company include the accounts of the Company and its wholly owned subsidiaries, Diamond Anvil Designs, LLC Deity Corporation, Vivis Corporation (Vivis), and Neutra Life Sciences, LLC, from the date of their formations or acquisition. Significant intercompany transactions have been eliminated in consolidation.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

All cash, other than held in escrow, is maintained with a major financial institution in the United States. Deposits with this bank may exceed the amount of insurance provided on such deposits. Temporary cash investments with an original maturity of three months or less are considered to be cash equivalents. Cash and cash equivalents were \$56,766 and \$36,743 at April 30, 2025 and January 31, 2025, respectively.

Accounts Receivable

Accounts receivable is carried at their estimated collectible amounts. Accounts receivable is periodically evaluated for collectability based on past credit history with customers and their current financial condition. The Company had an allowance of \$0 at April 30, 2025 and January 31, 2025.

Inventory

Inventory is comprised of packaging and supplies and at times raw materials. Inventory is valued at cost, based on the average cost method, unless and until the net realizable value for the inventory is lower than cost, in which case an allowance is established to reduce the valuation to the net realizable value. As of April 31, 2025 and January 31, 2025, the Company recognized an inventory impairment loss of \$0.

Property and Equipment, net

Property and equipment consist of equipment used to manufacture the Company's products and is presented at cost. Depreciation is recognized over the useful life of the equipment on a straight-line basis over five and three years beginning when the asset is put in service.

Impairment of long-lived assets

Long-lived assets, including fixed assets and intangible assets, are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of the long-lived asset may not be recoverable. The carrying amount of a long-lived asset is not recoverable if it exceeds the sum of the undiscounted cash flows expected to result from the use and eventual disposition of the asset. If it is determined that an impairment loss has occurred, the loss is measured as the amount by which the carrying amount of the long-lived asset exceeds its fair value. The Company determined that there was no impairment of long-lived assets during the periods ended April 30, 2025 and January 31, 2025.

Revenue Recognition

The Company recognizes revenue in accordance with ASC Topic 606, Revenue From Contracts With Customers. Revenues are recognized when control of the promised goods or services is transferred to the customer in an amount that reflects the consideration the Company expects to be entitled to in exchange for transferring those goods or services. Revenue is recognized based on the following five step model:

- Identification of the contract with a customer
- Identification of the performance obligations in the contract
- Determination of the transaction price
- Allocation of the transaction price to the performance obligations in the contract
- Recognition of revenue when, or as, the Company satisfies a performance obligation

Product sales are recognized all of the following criteria are satisfied: (i) a contract with an end user exists which has commercial substance; (ii) it is probable the Company will collect the amount charged to the end user; and (iii) the Company has completed its performance obligation whereby the end user has obtained control of the product. A contract with commercial substance exists once the Company receives and accepts a purchase order or once it enters into a contract with an end user. If collectability is not probable, the sale is deferred and not recognized until collection is probable or payment is received. Control of products typically transfers when title and risk of ownership of the product has transferred to the customer. Payment is received before shipment of the product. Net revenues comprise gross revenues less customer discounts and allowances, actual and expected returns. Shipping charges billed to customers are included in net sales. Various taxes on the sale of products to customers are collected by the Company as an agent and remitted to the respective taxing authority. These taxes are presented on a net basis and recorded as a liability until remitted to the respective taxing authority. The Company allows for customers to return unopened products within 10 days in certain limited circumstances. There have been no refunds processed for returned product.

The Company also provides consulting services of business development. The revenue from this contract is recognized over time as the customer receives the benefit of the services under the contract.

The Company's subsidiary NLS also generates revenue from performing clinical trial services to pharmaceutical companies.

For the three months ended April 30, 2025, revenue from consulting income from business development consulting services totaled \$0, revenue from sales of CBD products totaled \$829, and revenue from clinical trial services totaled \$173,654. For the three months ended April 30, 2024, revenue from consulting income from business development consulting services to one customer \$29,420 and revenue from sales of CBD products totaled \$2,955.

Contract Costs

Costs incurred to obtain a customer contract are not material to the Company. The Company elected to apply the practical expedient to not capitalize contract costs to obtain contracts with a duration of one year or less, which are expensed and included within cost of goods and services.

Cost of Sales

Cost of sales includes all of the costs to purchase and assemble the Company's products, medical records and supplies, payroll costs of doctors and staff conducting clinical trials and patient stipend expense. Products are manufactured for the Company by third-party contractors, such costs represent the amounts invoiced by the contractors. Additionally, shipping costs are included in Cost of Sales in the Statements of Operations.

Earnings (Loss) per Common Share

We compute basic and diluted earnings per common share amounts in accordance with ASC Topic 260, *Earnings per Share*. The basic earnings (loss) per common share are calculated by dividing our net income available to common shareholders by the weighted average number of common shares outstanding during the year. The diluted earnings (loss) per common share are calculated by dividing our net income (loss) available to common shareholders by the diluted weighted average number of shares outstanding during the year. The diluted weighted average number of shares outstanding is the basic weighted number of shares adjusted as of the first of the year for any potentially dilutive debt or equity. There are no dilutive shares outstanding for any periods reported.

Mezzanine equity

Where ordinary or preferred shares are determined to be conditionally redeemable upon the occurrence of certain events that are not solely within the control of the issuer, and upon such event, the shares would become redeemable at the option of the holders, they are classified as ‘mezzanine equity’ (temporary equity). The purpose of this classification is to convey that such a security may not be permanently part of equity and could result in a demand for cash, securities or other assets of the entity in the future.

Subsequent events

The Company follows the guidance in Section 855-10-50 of the FASB Accounting Standards Codification for the disclosure of subsequent events. The Company will evaluate subsequent events through the date when the financial statements were issued. Pursuant to ASU 2010-09 of the FASB Accounting Standards Codification, the Company as an SEC filer considers its financial statements issued when they are widely distributed to users, such as through filing them on EDGAR.

Recently Adopted Accounting Pronouncements

From time to time, new accounting pronouncements are issued by the FASB or other standard setting bodies that are adopted by the Company as of the specified effective date. Unless otherwise discussed, the Company believes that the effect of recently issued standards that are not yet effective will not have a material effect on its financial position or results of operations upon adoption.

ASC Topic 280, “*Segment Reporting*,” requires annual and interim reporting for an enterprise’s operating segments and related disclosures about its products, services, geographic areas and major customers. An operating segment is defined as a component of an enterprise that engages in business activities from which it may earn revenues and expenses, and about which separate financial information is regularly evaluated by the chief operating decision maker in deciding how to allocate resources. In November 2023, the FASB issued ASU No. 2023-07, “*Segment Reporting (Topic 280): Improvements to Reportable Segment Disclosure*.” The ASU updates reportable segment disclosure requirements, primarily through requiring enhanced disclosures about significant segment expenses and information used to assess segment performance. The amendments do not change how segments are determined, aggregated, or how thresholds are applied to determine reportable segments. The Company adopted ASU No. 2023-07 during the year ended January 31, 2025.

In November 2024, the FASB issued ASU 2024-03, *Disaggregation of Income Statement Expenses (DISE)*, requiring additional disclosure of the nature of expenses included in the income statement. The new standard requires disclosures about specific types of expenses included in the expense captions presented on the face of the income statement as well as disclosures about selling expenses. The amendments in this update are effective for annual periods beginning after December 15, 2026 and interim periods within fiscal years beginning after December 15, 2027. Early adoption is permitted. The Company is currently evaluating the impact of our pending adoption of this standard on our consolidated financial statements.

Note 5. Related Party Transactions

During the three months ended April 30, 2025 and 2024, we incurred salary expense of \$25,000 to our CEO, Sydney Jim. In addition, we incurred commission expense of \$498 and \$1,773 during the three months ended April 30, 2025 and 2024 to Mr. Jim and owed a total of \$46,923 and \$46,425 in accrued commissions as of April 30, 2025 and January 31, 2025, respectively. During the three months ended April 30, 2025 and 2024, Mr. Jim paid expenses of \$0 and \$1,938, respectively, on behalf of the Company.

As of April 30, 2025 and January 31, 2025, we owed Mr. Jim, or entities controlled by him, \$516,322 and \$493,696 which is recorded on the balance sheet in “Accounts Payable – Related Party”, respectively, and \$12,314 in “Advances payable to related party”. This balance includes the commissions payable to Mr. Jim described above.

On March 11, 2022, the Company entered into a loan agreement for \$60,000 of proceeds with the holder of the Company’s Series A and B preferred stock. The loan is unsecured and bears interest at 6%. The Company will make monthly payments of \$4,240 per month beginning in April 2022 through the maturity at June 18, 2023. As of April 30, 2025 and January 31, 2025, the note principal balance was \$54,156 and accrued interest was \$9,642 and \$8,722, respectively. The Company has not made all required monthly payments under the note agreement to date and the loan is currently in default.

During the year ended January 31, 2022, the Company acquired the assets of Deity Corporation, a Texas corporation which the Sydney Jim, the Company’s CEO, had a controlling interest in that will produce hemp and cannabis products. The transaction was considered an asset acquisition, as there were no operations of Deity Corporation prior to the transaction. The Company received the formulas for certain hemp and cannabis-based products and a website to market the products that will be produced. In exchange, the Company will pay to Mr. Jim 60% of the revenue from Deity Corporation sales until a total of \$250,000 is reached, at which point the Company will pay 20% of Deity Corporation revenue to Mr. Jim.

On August 16, 2024, Neutra Life Sciences, LLC and Sydney Jim, the Company’s CEO entered into an independent contractor agreement whereby the contractor shall serve as CEO of Neutra Life Sciences, LLC, for a period of six months. As compensation for his services, the consultant will receive a monthly fee of \$12,000 and 100,000,000 shares of common stock. Also, he will receive 4.5% of gross revenue from all the projects he closes. If at any time he is no longer affiliated with the Company, the royalty amount will drop to 2.5% of gross revenue. Furthermore, he will receive 15% of gross revenue from VIVIS Corp and 2.5% of revenue of all Industry Sponsored Studies Awarded he closes and 5% of all clinical research sites referred to and closed by him for Neutra Life Sciences. Lastly, as acting President and Chief Executive Officer, he will receive 20% of net profits on a semi-annual basis if NLS has at least one fiscal quarter of operational cash reserves. A year-end bonus can be established by the President and CEO which can include cash plus restricted common stock. As of April 30, 2025, the consultant is owed a total of 100,000,000 shares of common stock with a fair value of \$20,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company’s consolidated balance sheet.

On February 18, 2025, the Company entered into a securities purchase agreement with Neutra Life Sciences, LLC, a Texas corporation which the Sydney Jim, the Company’s CEO, owns 100% of the outstanding equity securities. The transaction combined entities under common control as Sydney Jim controls both entities. Pursuant to the terms of the agreement, the Company acquired 1,000,000 shares, representing 100% of the outstanding equity securities of Neutra Life Sciences, a Texas Limited Liability Corporation, for \$900,000 payable in 180,000 shares of the Company’s convertible preferred stock. As of April 30, 2025, the 180,000 shares of preferred stock have not yet been designated, and the fair value is included in subscriptions payable on the Company’s consolidated balance sheet. The convertible preferred stock will be convertible into an aggregate of 9,000,000 shares of common stock.

Note 6. Advances and Notes Payable

As of April 30, 2025 and January 31, 2025, we had amounts due under advances of \$3,450 at each period. These advances are not collateralized, non-interest bearing and are due on demand.

On March 11, 2022, the Company entered into a loan agreement for \$60,000 of proceeds with the holder of the Company’s Series A and B preferred stock. The loan is unsecured and bears interest at 6%. The Company will make monthly payments of \$4,240 per month beginning in April 2022 through the maturity at June 18, 2023. As of April 30, 2025 and January 31, 2025, the note principal balance was \$54,156 and accrued interest was \$9,642 and \$8,722, respectively. The Company has not made all required monthly payments under the note agreement to date and the loan is currently in default.

As part of the securities purchase agreement with Neutra Life Sciences, LLC, the Company assumed a promissory note, dated February 5, 2025, with a third party for a total principal of \$125,000. The Company will pay 9.5% per annum, until the total principal is paid in full. The note will be repaid in 31 monthly consecutive principal and interest payments of \$4,445.44 each, beginning May 5, 2025. During the three months ended April 30, 2025, the Company repaid \$3,030. As of April 30, 2025, the balance owed on the note was \$121,970. Accrued interest on the note was \$0 as of April 30, 2025.

As part of the securities purchase agreement with Neutra Life Sciences, LLC, the Company assumed a promissory note, dated August 19, 2024, with a third party for a total principal of \$50,000. The Company will pay 20% per annum, until the total principal is paid in full. The note will be repaid in consecutive monthly installments of principal and interest payments of \$2,857.14 each, beginning in November, 2024. During the three months ended April 30, 2025, the Company repaid \$2,857.14. As of April 30, 2025, the balance owed on the note was \$47,143. Accrued interest on the note was \$4,483 as of April 30, 2025.

Note 7. Shareholders’ Equity

Series A Preferred Stock. In January 2020, our board of directors designated 50,000 shares of our preferred stock as Series A Preferred Stock which rank subordinate to all shares of common stock and do not have voting rights. The Series A Preferred Stock has a stated value of \$5 per share. The Series A Preferred Stock is entitled to receive dividends of 10% of the net profit of VIVIS Corporation. The

holders of the Series A Preferred Stock have the option to convert each share into 800 shares of common stock of the Company. As of April 30, 2025 and January 31, 2025, there are 50,000 shares of Series A Preferred Stock outstanding.

Series B Preferred Stock. In July 2020, our board of directors designated 10,000 shares of our preferred stock as Series B Preferred Stock which rank subordinate to all shares of common stock and do not have voting rights. The Series B Preferred Stock has a stated value of \$5 per share. The Series B Preferred Stock is entitled to receive dividends of 0.4% of the net profit of VIVIS Corporation. Holders of the Series B Preferred Stock have the option to convert each share into 800 shares of common stock. During the year ended January 31, 2021, the Company subscribed 10,000 shares of Series B Preferred Stock for cash proceeds of \$50,000. The shares were issued during the year ended January 31, 2022. As of April 30, 2025 and January 31, 2025, there are 10,000 shares of Series B Preferred Stock outstanding.

Series C Preferred Stock. In November 2020, our board of directors designated 40,000 shares of our preferred stock as Series C Preferred Stock which rank subordinate to all shares of common stock and do not have voting rights. The Series C Preferred Stock has a stated value of \$5 per share. The Series C Preferred Stock is entitled to receive dividends of 10% of the net profit of VIVIS Corporation. After the Series C Preferred Stock has received cumulative dividends of \$500,000, the dividend rate will reduce to 1%. Holders of the Series C Preferred Stock have the option to convert each share into 38 shares of common stock. During the year ended January 31, 2021, the Company subscribed 40,000 shares of Series B Preferred Stock for cash proceeds of \$200,000. The shares were issued during the year ended January 31, 2022. As of April 30, 2025 and January 31, 2025, there are 40,000 shares of Series C Preferred Stock outstanding.

Series E preferred stock issued for services

On November 13, 2015, our board of directors designated 1,000,000 shares of our preferred stock as Series E Preferred Stock. The Series E Preferred Stock is subordinated to our common stock. It does not receive dividends and does not participate in equity distributions. The Series E Preferred stock has 2 votes for each outstanding share of common stock in the company. As of April 30, 2025 and January 31, 2025, there are 1,000,000 shares Series E Preferred Stock outstanding. Dividends, when, as and if declared by the Board of Directors, shall be paid out of funds at the time legally available for such purposes.

Series F preferred stock issued for services

The Series F Preferred Stock is subordinated to our common stock and superior to all shares of Preferred Stock. It does not receive dividends and does not participate in equity distributions. The Series F Preferred stock retains 2/3 of the voting rights in the company. During the year ended January 31, 2021, the Company issued 1,000,000 shares of Series F Preferred Stock to Sydney Jim, our CEO, in exchange for services. As of the date of this report, there are 1,000,000 shares Series F Preferred Stock outstanding. As of April 30, 2025 and January 31, 2025, there are 1,000,000 shares of Series F Preferred Stock outstanding.

Series G convertible preferred stock

During the year ended January 31, 2024, the holders of the Series G convertible preferred stock converted 35,200 shares and accrued dividends of \$1,408 into 174,323,810 shares of common stock. The conversions were in accordance with the terms of the agreement and no gain or loss was recognized. As of April 30, 2025 and January 31, 2025, there were no shares of Series G convertible preferred stock outstanding.

Stock Subscription

On February 23, 2022, the Company sold 10,000 shares of preferred stock not yet designated for cash proceeds of \$50,000.

On February 18, 2025, the Company entered into a securities purchase agreement with Neutra Life Sciences, LLC, a Texas corporation which the Sydney Jim, the Company's CEO, owns 100% of the outstanding equity securities. The transaction combined entities under common control as Sydney Jim controls both entities. Pursuant to the terms of the agreement, the Company acquired 1,000,000 shares, representing 100% of the outstanding equity securities of Neutra Life Sciences, a Texas Limited Liability Corporation, for \$900,000 payable in 180,000 shares of the Company's convertible preferred stock. As of April 30, 2025, the 180,000 shares of preferred stock have not yet been designated, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet. The preferred stock will be convertible into 9,000,000 shares of common stock.

On August 16, 2024, Neutra Life Sciences, LLC and Sydney Jim, the Company's CEO entered into an independent contractor agreement whereby the contractor shall serve as CEO of Neutra Life Sciences, LLC, for a period of six months. As compensation for his services, the consultant will receive a monthly fee of \$12,000 and 100,000,000 shares of common stock. As of April 30, 2025, the consultant is owed a total of 100,000,000 shares with a fair value of \$20,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet.

On August 16, 2024, Neutra Life Sciences, LLC and a contractor entered into an independent contractor agreement whereby the contractor shall serve as Director of Clinical Operations of the Company, for a period of six months. As compensation for his services, the consultant will receive a bi-monthly fee of \$5,000 and 30,000,000 shares of common stock. As of April 30, 2025, the consultant is owed a total of 30,000,000 shares with a fair value of \$6,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet.

On August 16, 2024, Neutra Life Sciences, LLC and a contractor entered into an independent contractor agreement whereby the contractor shall serve as Administrator of the Company's clinical operations, for a period of six months. As compensation for his services, the consultant will receive a bi-monthly fee of \$1,750 and 5,000,000 shares of common stock. As of April 30, 2025, the consultant is owed a total of 5,000,000 shares with a fair value of \$1,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet.

Note 8. Commitments and Contingencies

Legal Contingencies

From time to time, we may be involved in various disputes and litigation matters that arise in the ordinary course of business. The Company is currently not a party to any material legal proceedings.

Commitments

The Company follows ASC 450-20, *Loss Contingencies*, to report accounting for contingencies. Liabilities for loss contingencies arising from claims, assessments, litigation, fines and penalties and other sources are recorded when it is probable that a liability has been incurred and the amount of the assessment can be reasonably estimated.

As discussed in more detail in Note 5, the Company agreed to pay 60% of all revenue from Deity Corporation to Sydney Jim, the Company's CEO, up until a total of \$250,000 is paid to Mr. Jim, at which point he will be entitled to 20% of revenue from Deity Corporation.

On August 16, 2024, Neutra Life Sciences, LLC and Sydney Jim, the Company's CEO entered into an independent contractor agreement whereby the contractor shall serve as CEO of Neutra Life Sciences, LLC, for a period of six months. As compensation for his services, the consultant will receive a monthly fee of \$12,000 and 100,000,000 shares of common stock. Also, he will receive 4.5% of gross revenue from all the projects he closes. If at any time he is no longer affiliated with the Company, the royalty amount will drop to 2.5% of gross revenue. Furthermore, he will receive 15% of gross revenue from VIVIS Corp and 2.5% of revenue of all Industry Sponsored Studies Awarded he closes and 5% of all clinical research sites referred to and closed by him for Neutra Life Sciences. Lastly, as acting President and Chief Executive Officer, he will receive 20% of net profits on a semi-annual basis if NLS has at least one fiscal quarter of operational cash reserves. A year-end bonus can be established by the President and CEO which can include cash plus restricted common stock. As of April 30, 2025, the consultant is owed a total of 100,000,000 shares of common stock with a fair value of \$20,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet.

On August 16, 2024, Neutra Life Sciences, LLC and a contractor entered into an independent contractor agreement whereby the contractor shall serve as Director of Clinical Operations of the Company, for a period of six months. As compensation for his services, the consultant will receive a bi-monthly fee of \$5,000 and 30,000,000 shares of common stock. Also, the contractor will receive 2% of gross revenue from the clinical research visit revenue for as long as the contractor is providing services for NLS. If at any time the contractor is no longer affiliated with NLS, the royalty amount will drop to 1% of gross revenue from the clinical research visit revenue. In addition, all contracted clinical research sites referred to and closed by the Contractor, the Contractor will receive a Quarterly Bonus Compensation of 4% of clinical research visit revenue. Lastly, as acting Director of Clinical Operations of NLS, the Contractor will receive 5% of net profits on a semi-annual basis if NLS has at least 1 fiscal quarter of operational cash reserves. A year-end bonus can be established by the President and CEO which can include cash plus restricted common stock. As of April 30, 2025, the consultant is owed a total of 30,000,000 shares with a fair value of \$6,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet.

On August 16, 2024, Neutra Life Sciences, LLC and a contractor entered into an independent contractor agreement whereby the contractor shall serve as Administrator of the Company's clinical operations, for a period of six months. As compensation for his services, the consultant will receive a bi-monthly fee of \$1,750 and 5,000,000 shares of common stock. Also, a year-end bonus can be established by the President and CEO which can include cash plus restricted common stock. As of April 30, 2025, the consultant is owed a total of 5,000,000 shares with a fair value of \$1,000, based on the common stock price on the grant date. The shares have not been issued to date, and the fair value is included in subscriptions payable on the Company's consolidated balance sheet.

There were no other known commitments or contingencies as of April 30, 2025 and January 31, 2025.
