Effective December 4, 2025, Sean Nathan Lloyd resigned from the Board of Directors and from his offices as President, Chief Executive Officer, Secretary and Treasurer of the company and Dr. Abel Haque was elected to the Board of Directors and to the positions of President and Chief Executive Officer, Secretary and Treasurer of the company. Contemporaneously with Mr. Lloyd's resignations, he transferred 70,000,000 shares of common stock in the company as follows: 20,000,000 shares to Dr. Abel Haque and 50,000,000 shares to Vost Holdings Ltd. See Item 2, below.

Effective December 4, 2025, Vost Holdings Ltd., a company owned and managed by Mike Sturdy, acquired from Sean Nathan Lloyd 50,000,000 shares of the company's common stock to add to Vost Holdings Ltd.'s prior holdings of 5,400,000 shares of common stock and 2,000,000 shares of the company's Series D Preferred Stock, resulting in a change of control of

- ii. The consummation of the sale or disposition by the Company of all or substantially all of the Company's assets;
- iii. A change in the composition of the Board occurring within a two (2)-year period, as a result of which fewer than a majority of the directors are directors immediately prior to such change; or
- iv. The consummation of a merger or consolidation of the Company with any other corporation, other than a merger or consolidation which would result in the voting securities of the Company outstanding immediately prior thereto continuing to represent (either by remaining outstanding or by being converted into voting securities of the surviving entity or its parent) at least fifty percent (50%) of the total voting power represented by the voting securities of the Company or such surviving entity or its parent outstanding immediately after such merger or consolidation.
