On November 17, 2025 Synergy Management Group, LLC signed a purchase agreement with Prudence & Development Co., Ltd. to sell the controlling interest in the company through Ninety Million (90,000,000) Shares of Common Stock. As part of the transaction Lifang Zhu was elected as Director, CEO, President and Secretary and Benjamin Berry resigned all positions with the company. A payment was made January 12, 2026 triggering this change of control disclosure and the company anticipates the transaction closing in the coming days.

2. The name(s) of person(s) who acquired control and person(s) from whom control was assumed. For corporations or other business entities, please provide the name(s) of person(s) beneficially owning or controlling such corporations or entities.²

Prudence & Development Co., Ltd. is a private corporation controlled by Xuwei Zhu. Lifang Zhu is the officer and representative of Prudence & Development Co., Ltd. Synergy Management Group, LLC is a single member LLC controlled by Benjamin Berry.

- ii. The consummation of the sale or disposition by the Company of all or substantially all of the Company's assets;
- iii. A change in the composition of the Board occurring within a two (2)-year period, as a result of which fewer than a majority of the directors are directors immediately prior to such change; or
- iv. The consummation of a merger or consolidation of the Company with any other corporation, other than a merger or consolidation which would result in the voting securities of the Company outstanding immediately prior thereto continuing to represent (either by remaining outstanding or by being converted into voting securities of the surviving entity or its parent) at least fifty percent (50%) of the total voting power represented by the voting securities of the Company or such surviving entity or its parent outstanding immediately after such merger or consolidation.
