### **Termination of Custodian Proceedings**

On May 28, 2021, a petition was filed against the Corporation in the District Court of Clark County, Nevada, entitled “In the Matter of CTR Investments & Consulting, Inc., a Nevada corporation” under case number A-20-835470-C by Alpharidge Capital, LLC, along with an Application for Appointment of Custodian, after several attempts to locate prior management and revive the Corporation’s Nevada charter, which had been permanently revoked. On June 15, 2021, the District Court of Clark County, Nevada entered an Order Granting Application for Appointment of Alpharidge Capital, LLC as Custodian of the Corporation (the “Order”). Pursuant to the Order, the Alpharidge Capital, LLC (the “Custodian”) has the authority to take any actions on behalf of the Corporation, that are reasonable, prudent or for the benefit of pursuant to, including, but not limited to, issuing shares of stock and issuing new classes of stock, as well as entering in contracts on behalf of the Corporation. In addition, the Custodian, pursuant to the Order, is required to meet the requirements under the Nevada charter.

After determining that prior management had not petitioned the Court to terminate the Custodianship, on November 4, 2025 the Corporation filed a Motion to Discharge Custodianship with the Court. Based upon the Corporation’s Motion and finding that there was no opposition filed with the Court, on December 9, 2025, the Court ordered that the acts of the Custodian be approved and the Custodian be discharged. The Court further

ordered that the actions of the Corporation during the Custodianship be ratified and approved.


