On January 29, 2026, Orlando Hernandez, CEO and Director of the company, entered into a Stock Purchase Agreement with Red Gemini LLC., whereby Mr. Hernandez sold 20,000,000 common shares and 60,000 Convertible Series A preferred stock in exchange for cash resulting in a change of control for the company. The Change of control is effective as of January 29, 2026. As a result, Mr. Hernandez resigned as CEO and Director of the company and William Shane Dunn was appointed as CEO and sole Director of the company.

- iv. The consummation of a merger or consolidation of the Company with any other corporation, other than a merger or consolidation which would result in the voting securities of the Company outstanding immediately prior thereto continuing to represent (either by remaining outstanding or by being converted into voting securities of the surviving entity or its parent) at least fifty percent (50%) of the total voting power represented by the voting securities of the Company or such surviving entity or its parent outstanding immediately after such merger or consolidation.
