Ben Berry was appointed Receiver of the Corporation pursuant to an Order of the 157th Judicial District Court, Harris County, Texas, CAUSE NO. 202401723, on April 22, 2024.

Newberry Specialty Bakers, Inc., now known as Dajjalai Digital Technology Group Corp. (the "Company"), previously filed for protection under Chapter 11 of the U.S. Bankruptcy Code on October 13, 2017, which was later converted to Chapter 7 (Case No.4:2017-bk-44189, Bankr. N.D. Tex.). A trustee administered and liquidated the estate, and on June 15, 2022, the Bankruptcy Court entered its Final Decree approving the Trustee's Final Report and closing the case.

Subsequently, in connection with the receivership, on March 10, 2025, the District Court entered an Order establishing a claims bar date, after which any untimely claims are forever barred.

As a result of the bankruptcy proceedings and subsequent receivership, all known creditor claims were administered, and no further liabilities remain. Accordingly, the Company recognizes no outstanding debt obligations and no accumulated deficit carried forward from periods prior to the bankruptcy. The Company's financial statements will reflect a fresh start with no legacy liabilities, consistent with its reinstated and debt-free status.

# DAJIALAI DIGITAL TECHNOLOGY GROUP CORP.

## NOTES TO FINANCIAL STATEMENTS

### FOR THE YEAR ENDED DECEMBER 31, 2025

#### 1. Nature of operations

Dajialai Digital Technology Group Corp. (the “Company”) is a corporation organized under the laws of the United States. The Company is currently a shell company with no significant operations.

In the fourth quarter of 2025, there was a change in control, and new management assumed control of the Company. The Company plans to develop its business through its affiliation with Dajialai, a business operating in the People’s Republic of China.

Dajialai operates as a vertical B2B integrated service platform in the smart city sector, utilizing a business model that combines product transactions, on-site services, and talent delivery. The platform operates through a nationwide network that includes over 150 provincial centers, more than 400 city partner centers, and over 10,000 certified service providers. Through this network, the platform is designed to provide on-site service response capabilities across various regions in China.

To support future operations and potential expansion, the Company may seek additional financing. However, there can be no assurance that such financing will be available on acceptable terms, or at all.

#### 2. Summary of significant accounting policies

##### Basis of Presentation

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

##### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. The most significant assumptions and estimates relate to the valuation of equity issued for services. Actual results could differ from these estimates.

##### Revenue Recognition

The Company recognizes revenue in accordance with Accounting Standards Update (“ASU”) 2014-09, “*Revenue from contracts with customers*,” (Topic 606). Revenue is recognized when a customer obtains control of promised goods or services. In addition, the standard requires disclosure of the nature, amount, timing, and uncertainty of revenue and cash flows arising from contracts with customers. The amount of revenue that is recorded reflects the consideration that the Company expects to receive in exchange for those goods. The Company applies the following five-step model in order to determine this amount: (i) identification of the promised goods in the contract; (ii) determination of whether the promised goods are performance obligations, including whether they are distinct in the context of the contract; (iii) measurement of the transaction price, including the constraint on variable consideration; (iv) allocation of the transaction price to the performance obligations; and (v) recognition of revenue when (or as) the Company satisfies each performance obligation.

The Company only applies the five-step model to contracts when it is probable that the entity will collect the consideration it is entitled to in exchange for the goods or services it transfers to the customer. Once a contract is determined to be within the scope of Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 606 at contract inception, the Company reviews the contract to determine which performance obligations the Company must deliver and which of these performance obligations are distinct. The Company expects to recognize revenues as the amount of the transaction price that is allocated to the respective performance obligation when the performance obligation is satisfied or as it is satisfied.

### Fair Value Measurements and Fair Value of Financial Instruments

The Company adopted ASC Topic 820, *Fair Value Measurements*. ASC Topic 820 clarifies the definition of fair value, prescribes methods for measuring fair value, and establishes a fair value hierarchy to classify the inputs used in measuring fair value as follows:

Level 1: Inputs are unadjusted quoted prices in active markets for identical assets or liabilities available at the measurement date.

Level 2: Inputs are unadjusted quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in markets that are not active, inputs other than quoted prices that are observable, and inputs derived from or corroborated by observable market data.

Level 3: Inputs are unobservable inputs which reflect the reporting entity's own assumptions on what assumptions the market participants would use in pricing the asset or liability based on the best available information.

The estimated fair value of certain financial instruments, including all current liabilities are carried at historical cost basis, which approximates their fair values because of the short-term nature of these instruments.

### Fair Value of Financial Instruments

ASC subtopic 825-10, *Financial Instruments* ("ASC 825-10") requires disclosure of the fair value of certain financial instruments. The carrying value of cash and cash equivalents, accounts payable and accrued liabilities when reflected in the balance sheets, approximate fair value because of the short-term maturity of these instruments. All other significant financial assets, financial liabilities and equity instruments of the Company are either recognized or disclosed in the financial statements together with other information relevant for making a reasonable assessment of future cash flows, interest rate risk and credit risk. Where practicable the fair values of financial assets and financial liabilities have been determined and disclosed; otherwise only available information pertinent to fair value has been disclosed. The Company follows ASC subtopic 820-10, *Fair Value Measurements and Disclosures* ("ASC 820-10") and ASC 825-10, which permits entities to choose to measure many financial instruments and certain other items at fair value.

### Cash and Cash Equivalents

For purposes of the Statements of Cash Flows, the Company considers highly liquid investments with an original maturity of three months or less to be cash equivalents.

### Income Taxes

Income taxes are accounted for under the asset and liability method. Deferred tax assets and liabilities are recognized for the future tax consequences attributable to differences between the financial statement carrying amounts of existing assets and liabilities and their respective tax bases and operating loss, capital loss and tax credit carryforwards. Deferred tax assets and liabilities are measured using enacted tax rates expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled. The effect on deferred tax assets and liabilities of a change in tax rates is recognized in income in the period that includes the enactment date.

The Company recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs. The Company records interest and penalties related to unrecognized tax benefits as a component of general and administrative expenses. Our federal tax return and any state tax returns are not currently under examination.

The Company has adopted FASB ASC 740-10, *Accounting for Income Taxes*, which requires an asset and liability approach to financial accounting and reporting for income taxes. Deferred income tax assets and liabilities are computed annually from differences between the financial statement and tax basis of assets and liabilities that will result in taxable or deductible amounts in the future based on enacted tax laws and rates applicable to the periods in which the differences are expected to affect taxable income. Valuation allowances are established when necessary to reduce deferred tax assets to the amount expected to be realized.

#### Net Income (Loss) Per Common Share

The Company computes loss per common share, in accordance with FASB ASC Topic 260, *Earnings Per Share*, which requires dual presentation of basic and diluted earnings per share. Basic income or loss per common share is computed by dividing net income or loss by the weighted average number of common shares outstanding during the period. Diluted income or loss per common share is computed by dividing net income or loss by the weighted average number of common shares outstanding, plus the issuance of common shares, if dilutive, that could result from the exercise of outstanding stock options and warrants.

#### Recent Accounting Pronouncements

The Company has implemented all new accounting pronouncements that are in effect. These pronouncements did not have any material impact on the financial statements unless otherwise disclosed, and the Company does not believe that there are any other new accounting pronouncements that have been issued that might have a material impact on its financial position or results of operations.

### **3. Going concern**

The accompanying financial statements have been prepared on a going concern basis. For the year ended December 31, 2025, the Company had a net loss of \$35,027, had \$0 in working capital, and an accumulated deficit of \$47,298. These matters raise substantial doubt about the Company's ability to continue as a going concern for a period of one year from the date of this filing. The Company's ability to continue as a going concern is dependent upon its ability to obtain the necessary financing to meet its obligations and repay its liabilities arising from normal business operations when they come due, to fund possible future acquisitions, and to generate profitable operations in the future. Management plans to provide for the Company's capital requirements by continuing to issue additional equity and debt securities. The outcome of these matters cannot be predicted at this time and there are no assurances that, if achieved, the Company will have sufficient funds to execute its business plan or generate positive operating results. The financial statements do not include any adjustments that might result from the outcome of this uncertainty.

### **4. Commitments and contingencies**

During the normal course of business, the Company may be exposed to litigation. When the Company becomes aware of potential litigation, it evaluates the merits of the case in accordance with FASB ASC 450-20-50, *Contingencies*. The Company evaluates its exposure to the matter, possible legal or settlement strategies and the likelihood of an unfavorable outcome. If the Company determines that an unfavorable outcome is probable and can be reasonably estimated, it establishes the necessary accruals. As of December 31, 2025, the Company is not aware of any contingent liabilities that should be reflected in the financial statements.

### **5. Related party transactions**

During the year ended December 31, 2025, the Company incurred operating expenses totaling \$13,767, which were paid on behalf of the Company by the Company's president.

Accordingly, the Company recorded a liability of \$13,767 as due to related party as of December 31, 2025.

## **6. Operating expenses**

During the year ended December 31, 2025, the Company incurred operating expenses totaling \$13,767, primarily consisting of:

- DTC eligibility fees
- FINRA filing fees
- Transfer agent fees
- CUSIP issuance fees

## **7. Stock issued for services**

During the year ended December 31, 2025, the Company issued shares of its common stock and preferred stock to certain individuals and/or entities in exchange for services provided to the Company.

The Company recognized stock-based compensation of approximately \$21,260, which has been included in operating expenses.

## **8. Equity**

### ***Preferred Stock***

The Company has 2,000,000 Shares of Preferred Stock authorized, and 1,000,000 Shares of Preferred Stock issued and outstanding with a par value of \$0.001.

Series A — The Series A Preferred has the following designations:

- Each share of preferred stock is convertible into 1,000 shares of common stock.
- The holders are not entitled to receive dividends
- Voting: The holder of this Series of Preferred shall vote with other classes on a converted share basis.
