RECEIPT OF SETTLEMENT PROCEEDS AND SATISFACTION OF INDEBTEDNESS

March 31, 2026. CeCors, Inc. (“CeCors” or the “Company”)(OTCMarkets: CEOS) provides the following update regarding the Settlement Agreement and Mutual Release dated September 9, 2025 (the “Settlement Agreement”), as previously disclosed in the Company’s Notice of Material Event dated February 18, 2026 .

Under the terms of the Settlement Agreement, VetComm, ROI Ventures, and Ms. Kate Monroe (collectively, the “Monroe Parties”) agreed to pay the Company aggregate settlement consideration of **US\$5,250,000**, payable in installments over a 240-day period.

As of February 18, 2026, the Company had received **US\$2,750,000** in aggregate proceeds under the Settlement Agreement. The Monroe Parties subsequently failed to make a scheduled installment payment of **US\$1,000,000** due in January 2026, resulting in an event of default.

Following the default, the Company issued notice and entered into a Forbearance Agreement dated March 4, 2026 (the “Forbearance Agreement”) with the Monroe Parties . In connection with the Forbearance Agreement, the Company received an additional **US\$250,000** payment, which was applied toward the outstanding settlement obligations. The Forbearance Agreement provided for, among other things: (i) acknowledgment of the outstanding indebtedness, (ii) accrual of default interest on unpaid amounts, and (iii) a requirement that the Monroe Parties complete payment of the remaining balance within a defined forbearance period, subject to a negotiated discount upon timely payment.

The Company confirms that it has received a further wire payment in the amount of **US\$2,143,561.24** on March 31, 2026. This payment represents the final settlement amount

determined in accordance with the Forbearance Agreement, after giving effect to accrued default interest, fees, and the agreed discount for timely repayment.

In total, the Company has received aggregate proceeds of approximately **US\$5,143,561.24** under the Settlement Agreement and related Forbearance Agreement.

Upon receipt of such final payment, all outstanding indebtedness owing to the Company under the Settlement Agreement has been satisfied in full. In accordance with the Forbearance Agreement, all existing defaults have been cured and released, and the Company's security interests in the assets of VetComm will be discharged.

The Company has no further economic interest in VetComm and no additional amounts remain payable under the Settlement Agreement.

The Company intends to reflect the final settlement and related accounting treatment in its forthcoming financial statements and disclosures.

The Company will continue to provide updates as appropriate.
