GEO JS Tech Group Corp. started as an exploration stage company engaged in procuring and delivering commodities in the international market with a primary focus on iron ore and gold. Joint venture and licensing rights to iron ore mines in Mexico and gold mines in New Guinea established the base of operations since the company's formation. Strategic relationships directly with end users in China for the delivery of iron ore has been a staple of business as iron ore is the main source of primary iron minerals required for the global iron and steel industries. It is essential as part of the production process of steel, which is critical to the global economy as steel is used in such items as ships, buildings, cars, appliances and many other products.

The Company is expanding operations to include the procurement and recycling of scrap metal and PET (Polyethylene Terephthalate) plastics. Scrap metals are shredded and separated into ferrous metal, nonferrous metal and non-metallic material such as plastic and foam. Those separated materials are sold for various uses. PET plastics are crushed, washed, separated, dried and shredded into small fragments. Some of these fragments are sold as PET flakes where as others are further processed to remove residues such as original contents, labels and caps to be sold as pure PET fragments.
