FINAL RESOLUTION OF DOMINION LITIGATION

The Company's prior public disclosures filed with the OTC Markets state that Michael J. Lindell, the Company's Chairman, Chief Executive Officer and controlling stockholder, was a defendant in *US Dominion, Inc., et al. v. My Pillow, Inc., et al.*, Case No. 1:21-cv-00445-CJN-MAU, pending in the United States District Court for the District of Columbia (the "Dominion Litigation"). Neither the Company nor any of its subsidiaries was a party to the Dominion Litigation.

On June 22, 2026, plaintiffs Liberty Vote Holdings Inc., Liberty Vote USA Inc. and Dominion Voting Systems Corporation and defendants My Pillow, Inc. and Michael J. Lindell filed a stipulation pursuant to Rule 41(a)(1)(A)(ii) of the Federal Rules of Civil Procedure dismissing, with prejudice, all claims and causes of action asserted by the plaintiffs against the defendants, permanently and finally concluding the action. Under the stipulation, each party is responsible for its own attorneys' fees, expenses and costs.

Liberty Vote publicly stated that the parties reached a confidential settlement. With the dismissal with prejudice, the Dominion Litigation is fully and finally concluded, and the risk previously disclosed concerning the possibility of an adverse judgment against Mr. Lindell in that action has been eliminated. The Company believes that the conclusion of this long-running matter is a welcome development that removes a significant uncertainty and allows Mr. Lindell and the Company's management to continue to devote their attention to the Company's conservative media business, its audience and its growth initiatives.
