

This guide is designed to help you complete the OTCQX International Application using <u>Gateway.otcmarkets.com</u>. Gateway is our online platform to apply to OTCQX and securely upload documents that contain personal information.

Gather Materials

Before you begin the application, have some materials ready including:

- List of your Officers, Directors and 5% Control Persons (owning more than 5%), including their date of birth and home address (City, State and Country only) for background check purposes.
- Number of shares owned by Officers,
 Directors and 5% Control Persons
- Recent shareholder list issued by your Registrar or Transfer Agent
- Company's corporate logo (minimum size of 72 DPI, maximum of 20 MB)

Create an Account
Visit Gateway.otcmarkets.com to sign in or create a new account to get started.

New to OTC Markets? Select "Create a New Account" — you'll be asked to provide your Name, Email, Phone & Create a Password

Have an OTCIQ.com account? Use your OTCIQ.com User Name & Password for Gateway

Start a New Application

Next select OTCQX International.

There are 15 sections in the application.

Some information may prepopulate if we already have a profile for your company.

- 1. <u>Company Information</u>: Basic information about your company including address, contact and home exchange information
- 2. Eligibility Standards: Confirm company's audited financials, ongoing operations, etc.



- 3. <u>Reporting Standards</u>: Confirm applicable Reporting Standard: International Reporting or SEC Reporting
- 4. <u>Financial Standards</u>: Determine financial eligibility by answering questions within an interactive widget
- 5. Officers, Directors, & Control Persons: Provide names and contact information
- 6. Service Providers: Information on the Securities Counsel, Investor Relations Firm, etc.
- 7. <u>Designate Contacts</u>: Identify key company contacts for compliance and billing purposes
- 8. Security Details: Number of shares issued, restricted and in the public float
- 9. <u>Security Ownership</u>: Number of shares owned by officers, directors and 5% Control Persons.
- 10. <u>Legal/Disciplinary History</u>: Description of any company related legal proceedings
- 11. Optional Services: Option to sign up for a Virtual Investor Conference
- 12. <u>Background Check Authorization</u>: Provide date of birth and address (city, state & country only) for officers, directors and 5% Control Persons
- 13. <u>Supporting Documents</u>: Upload a recent shareholder list and company logo
- 14. Review and Sign: Confirm application data before submission
- 15. <u>Pay and Submit</u>: Pay the <u>application fee</u> via wire or credit card and submit the completed application
