# ***1 OTC Quote History File***

## ***1.1 Overview***

The OTC Markets Group OTC Quote History file provides tick by tick quote information for quotations submitted to the OTC Link inter-dealer quotation system. The file includes quote attribute information (e.g. timestamp, price, size) for individual market participant quotes and 'inside market' quotes generated by the OTC Link quotation system.

The OTC Quote History file has two distinct versions: the first only includes quotes entered into the OTC Link ATS directly while the second incorporates third party quotes from the Global OTC interdealer quotation system (ARCA). Access to the version containing Global OTC data requires additional licensing with NYSE/ICE.

OTC Quote History files are made available daily at ~9:45 PM – on every trading day. File types and delivery methods are outlined in section 1.2 and 1.4.

## ***1.2 File Types***

OTC Quote History Data files will be made available to customers in pipe delimited format. Files will be created on every trading day at 9:45 PM.

OTC Quote History Data files will be created with and without the cusip field included<sup>1</sup>. OTC Quote History Data file naming convention is as follows:

- CUSIP included: MMDDYYYY\_CUSIP.txt.gz
- CUSIP not included: MMDDYYYY.txt.gz

The first row of the pipe delimited file includes column labels. The file will be zipped to reduce file size. Unpacked file size is approximately 21.5 GB.

<sup>1</sup> CUSIP is a unique nine-character alphanumeric code appearing on the face of each stock or bond certificate that is assigned to a security. CUSIP numbers are the property of the American Bankers Association (ABA) and are administered by Factset. Since OTC Markets Group neither owns nor controls CUSIP numbers, distributors cannot be authorized to receive the daily list or fundamental data files including CUSIP data unless they have a daily license in place with CUSIP. Distributors please note: OTC Markets Group is not responsible for obtaining written approval from CUSIP prior to authorizing data distributors to externally redistribute CUSIP data; it is the responsibility of the data distributor to obtain such CUSIP permission for their downstream customers.

OTC Quote History Data files will be made available to customers via SFTP. Files will be placed in a directory entitled 'otc\_history' at ~9:45 PM on trading days.
