

OTCQB STANDARDS RELEASE NO. 7 (AMENDMENT)

OTC Markets Group has published amendments to the OTCQB Standards.

Amendments

As of April 16, 2019, OTC Markets Group has made the following amendments to the OTCQB Standards.

- 1. The definition of Change in Control has been updated to fully describe in detail, the events that are considered a change in control of a company.
- 2. Failure to timely respond to OTC Markets Groups' requests for information has been added as a reason for which OTC Markets Group may remove a company from the OTCQB market.
- 3. The definition of OTC Markets Group has been updated to reflect our new address, 300 Vesey Street, 12th Floor, New York, NY 10282.

Effective Date of Amendment:

The new OTCQB Standards are scheduled to become effective for all OTCQB companies on April 16, 2019.
