Joining us today is Brian Fowler the President and CEO of Northstar Gold that trades on our OTCQB Venture Market under the ticker NSGCF. Based in Canada Northstar Gold Corp. is a public company focused on the exploration, development, and acquisition of quality exploration properties in the Abitibi Greenstone Belt and the Kirkland Lake district. Brian, thanks so much for joining us today.

So, Brian give us a little info about your personal and professional background.

#### Brian Fowler

Well I'm a geologist with over 40 years of experience in major and junior gold and base metal exploration and development concerns. I'm based in Vancouver about but 13 of those years that I've been working were with major on a global basis with plaster domink and there I was in a variety of managerial and technical roles between 1991 and 2004 thereafter I kind of worked for quadro mining for a short period of time and I also worked as a mining analyst for quest capital for a couple of years since 2006 I've worked primarily in the junior resource sector as a. As a mining executive and I've formed a number of gold and copper expiration public companies that I've been active with since that time I joined http://northstargoldcorp in November Twenty Nineteen as President and CEO and director. And spearheaded taken the company public by way of IPO in late 2020, so I've pretty much been focused entirely on Northstar since then.

So can you update us on developments for your flagship project in Kirkland Lake

#### Brian Fowler

Yeah, certainly Nothstar's flagship project is the hundred percent owned Miller Gold property it's situated eighteen kilometers southeast of Kirkland Lake and Agnico Eagles Mccasa Smc Project Mccasa has produced more than five million ounces of gold at an average headgrade of half an ounce since , 1933 and it continues to be 1 of the highest grade gold mines in the world. Our Miller Gold property shares a number of very important geological characteristics of Macassa. This includes a similar age and style of host rocks, controlling



mineralized minalization fault structures and the style of high grade gold tellurite mineralization in in quartz veins we acquired Miller. By staking in 2012 and since that time companies conducted a number of drilling campaigns targeting high-grade Kirkton style called telluride vein minalization and more recently lower grade near surface bulk tonnage. Gold mineralization in the allied cyanide gold zone and the nearby planet cyanite. Since acquisition between 2014 and 2021 Northstars drilled more than 19,000 meters of drilling in 93 holes on the property. More recently this spring between March 15<sup>th</sup> and April 27<sup>th</sup> we drilled just under two thousand meters and 8 holes in in a phase two a drill program following up near surface bulk tonnage. Gold discovery at the allied sinai gold zone in in 2020 this past fall we completed an additional 14 holes Twenty five hundred meters of drilling and a fairly large surface stripping program at Miller and we were successful in more than doubling the size of the allied sinite gold zone and we made a number of new gold discoveries as well. Unbelievably we're still waiting on some final assay results which we hope to announce next week. Drilling in 2021 was very successful at Miller and where we got intercepts up to 6.6 grants return gold over 117 meters in in 1 well in in hole 56 so yeah, our expiration efforts are definitely being rewarded.

And talk about the strategic advantages you have in the region.

Brian Fowler And Miller.

#### Brian Fowler

We have a number of strategic advantages in Miller I guess the number one advantage is our location. We're just eighteen kilometers from Kirkton Lake and it would road access to ignico's Mccasa mining complex. The high grade nature of gold telluroid minialization and Miller is and other distinct advantage high grade can forgive a lot of sins so to speak it can accommodate onsite concentrating and direct and cover direct shipping costs to nearby facilities which exist in the in the area. , such you know Miller doesn't have to be a standalone deposit to be amenmal to mining and production. We don't need three and a half million an ounces a goal to get things going there. We think that a million ounce threshold will be more than enough to warrant interest from our major. Neighbors on you know for production on a production basis and I guess the last thing that Miller's got going for is well it's a hundred percent owned by Northstar. So that just totally maximizes his shareholder value.



So excellent. So what trends are you seeing in the global gold markets with the current geopolitics. How are gold prices being affected with the concern of increasing inflation and the current oil market?

#### Brian Fowler

Well, that's a loaded question. We've got just when you think things are making sense in the oil and gold sectors. You know all hell broke loose with Russian aggression and in Ukraine. You know the markets are in a state of flux and even though gold is flirting with two thousand two thousand dollars an ounce price. A lot of juniors and small cap mines golds resource issuers you know they continue to be under sustained continue and sustained selling pressure. It's quite unusual. Over the coming weeks, I guess I suspect that we'll continue to see selling pressure on all fronts. But at the end of the day, I believe juniors with quality assets such as Miller Gold and our hundred percent own nearby Bryce property will help companies such as Northstar remain in the spotlight and you know and in positive territory.

# OTC Markets Group And what is in the pipeline for Northstar in 2022/

#### Brian Fowler

Well, as I mentioned earlier like many of our peers, we're experiencing epic assay result delays from our assay lab. So, we finished a 2021 Miller Drill programs last November and three and a half months later you know we're still waiting on results. This makes it really hard for a company to kind of maintain a share price and invest their interest even more so in in a volatile market. We're very close to announcing our final Miller results from 10 holes hopefully within a week or so. And our hopes are the market will like what adheres and this will provide Northstar the ability to raise sufficient capital to continue exploration and development at the allied sinai gold zone on the Miller property through additional drilling this coming summer., we all Northstar also owns a hundred percent interest in our Bryce property. That's situated thirty five kilometers southwest of Miller on the easterner, right? outbreak over the years between two 2009 and 2013 Northstar incurred more than \$4000000 in exploration expenditures at Bryce having drilled more than twenty two thousand meters in drilling targeting you know, similar exploration target as Miller and the intrusion- hostted gold type system but and also precious metals enriched VMS system past drilling on our what we call the Sunday creek porphyry established a large stockwork system stringer veins some high grade gold and definite bulk tonnage gold potential. We and intersected point nine grams gold over eighty meters including two grams gold over Twenty five and a half meters and 1 gram gold over fifty six meters in



the additional hall. So, we're definitely knocking on the door and we a pretty robust system by the looks of it drilling at the nearby Pike Lake vms zone you know we got two point four grams Gold three point four Grams silver and two percent Zinc over sixteen meters so we were really excited about Bryce this past year we spent \$200000 undertaking some geophysics and mapping and sampling and we're in the final throes of putting together of 43101 technical report which we hope to release here in the very near term so nowhere we're exploring you know the best mechanism to advance price and then be it option or spin out but you know but rest assured are my main focus is and will continue to be advancement and enlarging the Miller Gold Property
