Silver X Mining is an emerging silver producer in Latin America with assets in Peru and Ecuador. The company's flagship asset is the high-grade Nueva Recuperada Silver project located in Central Peru. Jose thank you so much for joining us.

Hi Cecilia, thank you for having us today.

So, Jose give us a little info about your personal and professional story and your international experience.

Jose Garcia

Yes, my name is Jose Garcia I'm the CEO of Silver X Mining Corp. I'm from Spain I studied mining engineering and early on I started a very international career I work in countries like Peru Chile Australia Switzerland Spain and I actually started different degrees including meaningful economics, global leadership and management at large to appoint the development my career when I wanted to become an entrepreneur a mining entrepreneur so we moved to Peru with a group of. Very system mining investors and we started a mining company that today is a reality, is Silver X.

So, tell us about your portfolio projects in Latin America?

Jose Garcia

Silver X is a company with assets in 2 countries Peru and Ecuador. In Peru we own a large silver district in Central Peru and also an early stage gold exploration project on top of that we actually have a gold exploration property in Equator. But the main one of the flagship is actually in novare ku perda which is a district scale project where we have processing facilities and more importantly, 2 mining units the one called Tagana which is what we are developing a mine and we are drilling and we are reaching full production in the next few months and then a second project called e peninsa which we are activating in the next few months and over 2023 so in other words, we are a silver company which is in production and in exploration.

Talk about your growth strategy. How do you approach organic growth versus opportunities with mergers and acquisitions.

Jose Garcia

We are a growth oriented company and we like that because we want to become relevant in the silver space and that means in other words to be 1 of those meatteer producers we like production so we are growing organically as I said earlier on. We have a district scale project and that district will sustain organic growth over the years but on top of that we are evaluating mergers and acquisitions. Why is that because we want to make it very quickly to the meattierer category meaning that we go from our current. Two million ounces of silver equivalent a year of production to basically 7 to 8 within the next three years that's our vision and that's our target.

What are you ESG commitments in the local communities your operate in

Jose Garcia

We as a group are very motivated around ESG. We typically say that we are a sustainable development company through mining and that's important because we live and work in central Peru, in the highlands and not only that mining is actually the main economic activity order there but we try to find every potential activity to provide a sort of multiple effect on the economy. Not only that we actually hired the local workers, we hired the local companies to provide all transportation and other ancillary service but actually every other service or sector around mining. We also hire from local companies and local people. We believe in the impact of mining in those regions and I believe that something that's going to keep growing over the years

2022 is going to be a remarkable year for Silver X. Why is that because this the consolidation of our story. Both being a producer and an explorer. The next few days you are going to see announcements about us studying operators again and greeting full commercial capacity imminently. That's good grades. That's good revenues and that's actually the good story about our company on top of that you'll keep seeing. Lots of good news about our exploration and the potential of
