# ***1 OTC Unsolicited Quote File***

## **1.1 Overview**

The OTC Markets Group OTC Unsolicited Quote file provides a daily snapshot of the unsolicited quote status and piggyback status for OTC securities. The unsolicited quote flag notes whether all the quotes associated with the respective security are unsolicited. If all quotes are unsolicited then the flag is set to true otherwise it is set to false. The piggyback status notes whether the security may be quoted under the 'piggyback exemption.' This exemption allows market participants to quote the security without filing a form 211 with FINRA.

Important Note: The OTC Unsolicited Quote is a snapshot of the unsolicited quote status as of ~7:15 AM. It is possible for the unsolicited quote status to change throughout the trading day. OTC Unsolicited Quote files are made available daily at ~7:15 AM – on every trading day. File types and delivery methods are outlined in section 1.2 and 1.4.

## **1.2 File Types**

OTC Unsolicited Quote files will be made available to customers in pipe delimited format. Files will be created on every trading day at 7:15 AM.

OTC Unsolicited Quote files will be created with the cusip field included<sup>1</sup>. The OTC Unsolicited Quote file naming convention is as follows:

- otcu\_unsolicited\_YYYYMMDD.txt

The first row of the pipe delimited file includes column labels. File size is approximately 1MB.

<sup>1</sup> CUSIP is a unique nine-character alphanumeric code appearing on the face of each stock or bond certificate that is assigned to a security by Standard & Poor's Corporation. CUSIP numbers are the property of the American Bankers Association (ABA) and are administered by Standard & Poor's. Since OTC Markets Group neither owns nor controls CUSIP numbers, distributors cannot be authorized to receive the daily list or fundamental data files including CUSIP data unless they have a daily license in place with CUSIP. Distributors please note: OTC Markets Group is not responsible for obtaining written approval from CUSIP prior to authorizing data distributors to externally redistribute CUSIP data; it is the responsibility of the data distributor to obtain such CUSIP permission for their downstream customers.

OTC Unsolicited Quote files will be made available to customers via FTP. Files will be placed in a directory entitled 'unsolicited\_quote' at ~7:15 AM on trading days.
