Global New Economy Summit took place successfully in the headquarters of the United Nations.



On May 23rd and 24th eastern Time U.S.A, Global new economy summit took place successfully in the conference hall 4 and Building 1 in the headquarters of the united Nations. The theme is *Public-Private Partnerships: Member State Initiatives to Ensure the Success of the SDGs-New Economy Forum by the Globalization Dialogues*. It includes a series of seminars which focus on the topic of communication about Public-Private

Partnerships and a series of summit and global new economy summit forum. The aim is to build cooperative partnership between the governments and the enterprises and promote united nation' s Sustainable development goals by member states.
