MINUTES OF THE ANNUAL AND EXTRAORDINARY GENERAL MEETINGS
HELD ON APRIL 30, 2024

Date, Time and Place: On April 30th, 2024, at 02:00 p.m., solely by digital means, pursuant to article 124, paragraph 2-A of Law No. 6,404, of December 15th, 1976 ("Brazilian Corporate Law") and Securities and Exchange Commission Resolution No. 81, of March 29th, 2022 ("RCVM 81"). Pursuant to article 5, paragraph 3 of RCVM 81, these Annual and Extraordinary General Meetings ("General Meetings") of Localiza Rent a Car S.A. ("Company") were deemed held at the Company's headquarters, located at Avenida Bernardo de Vasconcelos, nº 377, CEP: 31.150-000, City of Belo Horizonte, State of Minas Gerais.

Call Notice: Call Notice published in the newspaper "Diário do Comércio de Minas Gerais" in its printed editions of March 26th, April 9th and April 23rd, 2024, on pages 12, 06 and 14, respectively, and in its digital editions, on March 26th, April 9th and April 23rd, 2024, always on page 1, in all these publications, in accordance with the provisions of article 124 of the Brazilian Corporate Law.

Legal Publications: The Management Report and Financial Statements for the fiscal year ended December 31st, 2023, together with the Independent Auditors' Report prepared by PricewaterhouseCoopers Auditores Independentes Ltda., of the Directors' Statement on the Financial Statements, the Extract from the Minutes of the Audit, Risk and *Compliance* Committee and the Opinion of the Fiscal Council, were disclosed to the market on March 11th, 2024 through the *websites* of the CVM (www.gov.br/cvm), B3 S.A. - Bolsa, Balcão Brasil ("B3") (www.b3.com.br) and the Company's Investor Relations (www.localiza.com/ri), as well as being published on March 19th, 2024, on pages 09 to 20, in the newspaper Diário do Comércio de Minas Gerais, and in its digital edition, on the same date.

Quorum: Shareholders of registered common shares without par value representing (i) 74.84% of the total votes granted by the Company's voting shares at the Annual General Meeting; and (ii) 75.12% of the total votes granted by the Company's voting shares at the Extraordinary General Meeting, according to the records of the electronic remote participation system, pursuant to article 47, III of RCVM 81, and information contained in the analytical charts prepared by the bookkeeping agent and by the Company itself, pursuant to article 48, items I and II, of RCVM 81.

Legal Presence: Present were Mr. Eugênio Mattar, Chairman of the Board of Directors, Rodrigo Tavares Gonçalves de Sousa, Finance and Investor Relations Director, Guilherme Campos and Daniel Zappalá, representatives of PricewaterhouseCoopers Auditores Independentes Ltda., the Company's independent auditors, and Antônio de Pádua Soares Pelicarpó, Chairman of the Company's Fiscal Council.

Presiding Board: Mr. Eugênio Mattar took the role of chairman and invited Suzana Fagundes to act as secretary.

Reading of Documents and Drawing Up of Minutes: After verifying the quorum for the installation of the Meetings and waiving the reading of the Call Notice and the Synthetic Consolidated Voting Map of the votes cast by remote voting mechanism, disclosed to the market on April 29th, 2024, which were available for consultation by the shareholders present, under the terms of article 48, paragraph 4, of RCVM 81, the drawing up of these minutes in the form of a summary of the facts that occurred, in accordance with article 130, paragraph 1, of the Brazilian Corporate Law, was unanimously approved by those present and to publish them without the signatures of the shareholders, in accordance with article 130, paragraph 2, of the Brazilian Corporate Law.

I - ANNUAL GENERAL MEETING

Agenda (1) To acknowledge the Management's accounts and approve the Company's Financial Statements for the fiscal year ended December 31st, 2023, together with the Independent Auditors' Report and the Audit Board's Opinion; **(2)** To approve Management's proposal for the allocation of net income for the year ended December 31st, 2023 and the distribution of dividends; **(3)** To install the Fiscal Council; **(4)** Set the number of members that will make up the Fiscal Council; **(5)** Elect the members of the Fiscal Council; **(6)** Set the compensation of the Fiscal Council; and **(7)** Establish the Management's annual compensation.

Deliberations:

- 1) Approved, by a majority of votes, with 623,235,949 votes in favor, 562,120 votes against and 170,556,888 abstentions, including the abstentions of those legally prevented from voting, the Management's accounts, the Company's Financial Statements for the year ended December 31st, 2023, together with the Independent Auditors' Report and the Audit Board's Opinion;
- 2) Approved, by a majority of votes, with 786,645,262 votes in favor, 1,766,492 votes against and 5,943,203 abstentions, the Board of Directors' proposal to allocate the net profit for the year ending December 31st, 2023, of R\$ 1,805,566.284.37 (one billion, eight hundred and five million, five hundred and sixty-six thousand, two hundred and eighty-four reais and thirty-seven cents), of which: (i) R\$ 90,278,314.22 (ninety million, two hundred and seventy-eight thousand, three hundred and fourteen reais and twenty-two centavos) will be used to set up the Legal Reserve; (ii) R\$ 1.564,996,157.32 (one billion, five hundred and sixty-four million, nine hundred and ninety-six thousand, one hundred and fifty-seven reais and thirty-two cents) for remuneration to shareholders, distributed in advance as interest on equity attributed to the mandatory dividend, and (iii) R\$ 150.291,812.83 (one hundred and fifty million, two hundred and ninety-one thousand, eight hundred and twelve reais and eighty-three cents) to the statutory reserve called Reserve for Investments, in accordance with article 26, paragraph 2, (f) of the Company's Bylaws. There will be no distribution of additional dividends.

- 3) The installation of the Fiscal Council was approved by a majority vote, with 758,794,032 votes in favor, 19,846,465 votes against and 15,714,460 abstentions;
- 4) It was unanimously approved, with 779,919,779 votes in favor, 0 votes against and 14,435,178 abstentions, to set the number of members of the Fiscal Council at three (3) members;
- 5) The election of the following members and alternates was approved by majority vote, with a term of office extending until the annual general meeting that decides on the approval of the accounts for the financial year ending December 31st, 2024:
 - (i) **Carla Alessandra Trematore**, Brazilian, married, accountant, enrolled in the CPF under No. 248.855.668-86, holder of identity card No. 21.880.357-6, issued by the SSP/SP, with address at Rua Apinajés, no. 868, Apto. 71, Perdizes, CEP 05017-000, São Paulo, SP, for the position of effective member of the Company's Fiscal Council, with **Eder Carvalho Magalhães**, Brazilian, married, accountant, holder of Identity Card No. MG043.171/0-7/CRC, enrolled in the CPF under No. 637.838.356-15, with a business address at Rua Sinval de Sá, no. 70, Cidade Jardim, CEP

30380-070, Belo Horizonte, MG, with 707,730,004 votes in favor, 0 votes against and 86,624,953 abstentions;

- (ii) **Antônio de Pádua Soares Pelicarp**, Brazilian, married, accountant, enrolled in the CPF under No. 293.142.676-87, holder of identity card no. MG 718860, issued by the SSP/MG, with address at Rua Dr. Plínio de Moraes, No. 920, Apto. 201, Cidade Nova, CEP: 31.170-170, Belo Horizonte, MG, for the position of effective member of the Company's Fiscal Council, with **Márcio José Soares Lutterbach**, Brazilian, married, engineer, holder of Identity Card No. 04.729.476-4, enrolled in the CPF/MF under No. 668.054.147-68, with business address at Avenida Doutor Cardoso de Melo, 1.855, 15th floor, suite 151, room A, Vila Olímpia, CEP 04548-005, São Paulo, SP, with 751,996,481 votes in favor, 0 votes against and 42,358,476 abstentions ; and
- (iii) **Guilherme Bottrel Pereira Tostes**, Brazilian, married, accountant, holder of identity card CRC 082.058/O-0 and enrolled in the CPF under no. 016.446.957-58, resident and domiciled at Rua Vice Governador Rubens Berardo, 125 apto 702 Bl 2- Gávea, Rio de Janeiro, RJ, for the position of effective member of the Company's Fiscal Council, with **Maurício Graccho de Severiano Cardoso, Brazilian**, married, economist, enrolled in the CPF under No. 315.096.737-68, holder of Identity Card No. 8.644, issued by the Regional Council of Economics of Rio de Janeiro, with business address at Rua Visconde de Pirajá, 589/802, Ipanema, CEP 22410-003, Rio de Janeiro, RJ, with 493,506,694 votes in favor, 208,968,917 votes against and 91,879,346 abstentions.

It was noted that those elected to the Fiscal Council presented the documents proving that they met the eligibility requirements set out in Article 162 of the Brazilian Corporate Law.

The members of the Fiscal Council elected herein shall take office within thirty (30) days from the date hereof, by signing the respective instrument of investiture to be drawn up in the Company's own book, declaring their respective dismissal.

- 6) It was then approved by a majority of votes, with 767,222,661 votes in favor, 3,170,162 votes against and 23,962,134 abstentions, the compensation of the members of the Fiscal Council, set at 10% (ten percent) of the compensation attributed, on average, to each director, not including benefits, formal complaints and profit sharing, in addition to the mandatory reimbursement of travel and subsistence expenses necessary for the performance of the function, under the terms of paragraph 3 of article 162 of the Brazilian Corporate Law. Alternate members of the Audit Board will only be remunerated when they act as substitutes for effective members.
- 7) By a majority of the votes cast, with 745,846,251 votes in favor, 25,327,633 votes against and 23,181,073 abstentions, the amount of the overall annual compensation of the Board of Directors in the total amount of R\$140,000,000.00 (one hundred and forty million reais), net of social charges, for the financial year 2024 was approved, with the payment of the compensation to the Management for the period from January to April 2025 being authorized on the same basis as it is estimated to be paid in the 2024 financial year, limited to a maximum of 1/3 of this overall compensation for the said period.

II - EXTRAORDINARY GENERAL MEETING

Agenda: (1) To approve amendments to the article 3, the article 5, item (m) of article 12, the *caput*, paragraphs and items of article 21, the items of article 22 and item (a) of paragraph 2 of article 26 of the Company's Bylaws; and **(2)** To approve the proposed consolidation of the Company's Bylaws.

Deliberations:

- 1) Approved, by unanimous vote, with 788,099,548 votes in favor, 0 votes against and 9,270,156 abstentions, **(i)** the updating of the article 3 of the Bylaws, to include items "(h)" and "(i)" in order to include two new complementary activities to the Company's core business, namely: electronic security systems monitoring activities and non-financial intangible assets management activity; **(ii)**

the updating of the article 5 of the Bylaws, to reflect the capital increases carried out within the authorized capital limit, as well as through a primary public distribution offering of ordinary shares issued by the Company, duly ratified at the following Meetings of the Board of Directors: (a) Meeting of the Company's Board of Directors held on March 7th, 2023, the minutes of which were registered with the Board of Trade of the State of Minas Gerais ("JUCEMG") under No. 10754622, in the amount of R\$ 180,699.996.75 (one hundred and eighty million, six hundred and ninety-nine thousand, nine hundred and ninety-six reais and seventy-five cents); (b) Meeting of the Company's Board of Directors held on June 12th, 2023, the minutes of which were registered with JUCEMG under No. 10589767, in the amount of R\$ 180.963,132.90 (one hundred and eighty million, nine hundred and sixty-three thousand, one hundred and thirty-two reais and ninety cents); (c) Meeting of the Company's Board of Directors held on June 26th, 2023, with the minutes registered with JUCEMG under No. 10589795, in the amount of R\$ 4,500,000.079.68 (four billion, five hundred million, seventy-nine reais and sixty-eight cents); and (d) Meeting of the Company's Board of Directors held on December 13th, 2023, the minutes of which were registered with the JUCEMG under No. 10589795, in the amount of R\$ 364,537.872.03 (three hundred and sixty-four million, five hundred and thirty-seven thousand, eight hundred and seventy-two reais and three cents); and the Company's Board of Directors' Meeting held on March 11th, 2024, in the amount of R\$ 172,082,343.65 (one hundred and seventy-two million, eighty-two thousand, three hundred and forty-three reais and sixty-five cents). As a result, the Company's share capital is now R\$ 17,548,980,975.01 (seventeen billion, five hundred and forty-eight million, nine hundred and eighty thousand, nine hundred and seventy-five reais and one cent), divided into 1,071,889,858 (one billion, seventy-one million, eight hundred and eighty-nine thousand, eight hundred and fifty-eight) shares; (iii) the updating of item "(m)" of art. 12 of the Bylaws, to include the applicability of the plea referred to in the item, for subscription and payment of capital, also to direct and indirect wholly-owned subsidiaries located abroad; (iv) updating the main section, paragraphs and items of article 21 and the subparagraphs of article 22 of the Bylaws, for the reversal of the Statutory Audit Committee - CAE in compliance with the terms of CVM Resolution no. 23/21; and (v) updating article, 26, paragraph 2 (a) to adjust the text in accordance with article 193, paragraph 1 of the Brazilian Corporate Law.

- 2) The proposal to consolidate the Company's Bylaws to reflect the changes set out in the item above was approved unanimously by the votes cast, with 788,099,548 votes in favor, 0 votes against and 9,270,156 abstentions. The text of the Company's consolidated Bylaws, now approved in accordance with management's proposal, already contemplating the items indicated above, was authenticated by the Board, numbered and filed at the Company's headquarters, and will be filed in JUCEMG in a separate section to these minutes, as well as being made available on the CVM, B3 and Company websites.

Closing. There being no further to discuss, the Chairman thanked everyone for attending and closed the meeting, adjourning it to draw up this minute, which, having been read, discussed and found to be in order, were approved and signed by the Presiding Board. The final summary voting maps and the List of Shareholders present are attached as **Annexes I and II** to these minutes, respectively. The Company acknowledged receipt of the statement from the shareholder Caixa de Previdência dos Funcionários do Banco do Brasil - PREVI, which was authenticated by the Board in accordance with the law and is attached as **Annex III**. The recording of the Meetings and the votes cast by means of remote voting ballots were filed with the Company. Under the terms of article 47, paragraphs 1 and 2 of RCVM 81, the shareholders whose remote voting ballots were considered valid by the Company and the shareholders who registered their presence in the electronic remote participation system were considered to be present at the meeting and to have signed the minutes.
