

bebe stores, inc. Appoints New Chief Financial Officer

(OTC:BDST) (the "Company") today announced the appointment and promotion of Patrick Hurley, CPA, as the Chief Financial Officer (CFO) and Treasurer of the Company with an annual salary of \$190,000 and a target bonus up to 20 percent.
