### LETTER TO THE SHAREHOLDERS

November 6, 2023 NAPOLEONVILLE, LA

As your President and CEO I would like to bring our shareholders up to date on progress we made in October. As we previously reported we received forage analysis from our potential joint venture partners in India that showed that a critical component of our technology, lignin is of a significantly lower concentration than is found in bagasse grown in the USA. This makes bagasse from sugarcane varieties in India *significantly more digestible*. We have applied for a permit to allow for the importation of 2 Metric tons (4400 lbs) of bagasse. Shipping of the product from the Port of Mumbai will be transported by a container ship operated by Maresk. Its destination is the Port of New Orleans and will take about 28 days.

Once unloaded in Napoleonville at our facility, it will take one business day to process the raw bagasse using our technology. We will send a portion of the SGP+2.0™ to our test ranch in Jefferson, Texas. There, a portion will be fed to a control group of Beef Heifers for two weeks to validate the efficacy of SGP+2.0™ made with bagasse from India. The study will include weight gain, herd acceptability, manure scoring, absence of methane gases and other odors, milk production from lactating heifers, finish, coat quality, and more.

At the same time, they will arrange to have the container of the processed SGP+2.0™ picked up and shipped back to India so they may conduct their own tests on Dairy Cows. Milk fat is key in India, so it will be measured with other key parameters relative to dairy operations there. These parameters have been established and agreed upon. Given the same transit time we expect results of their testing by late February-early March 2024.

In the meantime, we are researching availability in India of the key components to replicate the operation/Footprint in Napoleonville. In mid-November, at their request, we will be hosting three representatives from the consortium in India to give them a tour of the plant and to discuss next steps. We are looking forward to meeting with them in person and laying the groundwork for a joint venture. Our interactions with our counterparts in India have been consistent, pragmatic, and serious. We are most pleased thus far.

To that end we have conducted an:
