

LETTER TO THE SHAREHOLDERS

March 18, 2024

Napoleonville, LA **(IFUS-OTC Markets)**

On March 7, 2024, I conducted an interview with Elizabeth Bourgeois of WAFB Channel 9, a CBS affiliate in Baton Rouge LA. A link to the interview is: <https://www.wafb.com/2024/03/07/new-innovative-cattle-feed-being-donated-north-texas/>

Since then, I have fielded calls from ranchers as far away as Ohio and Illinois as well as Oklahoma and of course, Texas. As a result of the interview being sent to several CBS affiliates throughout the USA, I was able to secure trucking to deliver the donated SGP+ to a relief collection site in Canadian, Texas to help the ranchers devastated by the wildfires. The 2 flatbed trucks are scheduled to depart from our plant Tuesday carrying a total 80,000 lbs. of SGP+.

As previously reported the test being conducted at the feedlot in Iowa is producing the desired results in a short period of time. The owner ordered two additional flat beds holding 40,000 lbs. each, which were shipped the week of March 4th. This is being tested on 550 head.

Again, as a result of the CBS story, I received a call from a rancher in Oklahoma who not only ordered a truckload of SGP+, but also asked to be a distributor to service ranches along the I-70 and I-40 corridor. He immediately placed an order for 40,000 lbs. for a rancher in Kansas.

He shared with me, that although he is located about one hour drive from the Texas wildfires, the purchases were based on lack of available feed due to the drought which is further exacerbated by the Texas wildfires.

The maps and other data show how widespread the drought is and the crops affected. Current prices of forage are also listed by state. Our pricing remains highly competitive.

Furthermore, we have a shipment pending for a trial to kick-off in Center, TX, which will be applied to 100 heifers, then expanded to the 400-heifer herd. Additionally, an expanded sales strategy now includes testing of SGP+ being conducted by nutritionists and other scientists affiliated with several universities.

All of these new customers and relationships are being added to our existing customer slate. To date, our customers, who are applying SGP+™ technology and

product as part of a ration management strategy, are reporting sustained success with their respective herds.

Finally, AgriGlow BioTech has reported that their shipment of bagasse produced at their sugar mills has departed the Port of Mumbai and is expected to arrive at the Port of New York on or about April 17, 2024. The cargo will be offloaded and driven to the Port of New Orleans. We have trucking arranged to pick up the cargo at the port and delivered to our plant in Napoleonville, LA. We plan to process their product and package for shipment back to India in less than a week using the same cargo company.
