

# OTC Pink® Basic Disclosure Guidelines

Federal securities laws, such as Rules 10b-5 and 15c2-11 of the Securities Exchange Act of 1934 ("Exchange Act") as well as Rule 144 of the Securities Act of 1933 ("Securities Act"), and state Blue Sky laws, require issuers to provide *adequate current information* to the public markets. With a view to encouraging compliance with these laws, OTC Markets Group has created these OTC Pink Basic Disclosure Guidelines. We use the basic disclosure information provided by OTC Pink companies under these guidelines to designate the appropriate tier in the OTC Pink marketplace: Current, Limited or No Information. OTC Markets Group may require companies with securities designated as Caveat Emptor to make additional disclosures in order to qualify for OTC Pink Current Information tier.

## **Qualifications for the OTC Pink - Current Information Tier**

Companies that make the information described below publicly available on a timely basis (90 days after fiscal year end for Annual Reports; 45 days after each fiscal quarter end for Quarterly Reports) qualify for the Current Information Tier. Financial reports must be prepared according to U.S. GAAP or IFRS, but are *not required to be audited* to qualify for the OTC Pink Current Information tier.

On August 3, 2017, subsequent to the date of the most recent quarterly report accompanying this filing, the Company announced that it intended to spin-off 20% of (the as yet unincorporated subsidiary) Hemp Beer Inc. to its shareholders, who would be awarded with a share dividend based upon their holdings of NSAV on the record date. Shareholders would receive approximately one share of Hemp Beer Inc. common stock for every 17 shares of NSAV common stock that they hold on the record date. It was intended that the dividend would be payable on or about September 5, 2017, but as of the date of this filing, the dividend had not yet been issued.

On April 24, 2017, the Board of Directors of Net Savings Link, Inc. declared a 10% stock dividend payable on or around June 29, 2017 to stockholders of record on June 1, 2017. As of the record date of this filing, the dividend had not yet been issued.

Net Savings Link's vision is the establishment of a fully integrated technology company, which provides turnkey technological solutions to the legal medical cannabis and hemp industries, as well as other areas of the medical industry. Over time, the Company plans, through both acquisition and development, to provide a wide range of services including without limitation: software solutions, e-commerce, financial services, advisory services, patents & trademarks, and information technology.

These technology solutions are broad-based, and range from medical bill payment apps to specialized inventory and transaction management software for the legal medical hemp and cannabis industry.

In addition to its technology assets, the Company has approved plans to develop cannabis and hemp based consumer products. The Company's first such offering will be a hemp based beer, anticipated to be marketed under the brand Tiger Hemp Beer.

On May 8, 2017, the Company entered into a definitive acquisition agreement with Danyi Zhang, a private individual, to acquire one-hundred percent (100%) of Shanghai Hua Si Tai Medical Consultation Company Limited, in exchange for a cash payment of eight-hundred thousand (\$800,000.00) U.S. Dollars.

On October 9, 2017, the Company and Danyi Zheng amended the May 8, 2017 definitive acquisition agreement. The Company will now acquire seventy percent (70%) of Shanghai Hua Si Tai Medical Consultation Company Limited, in exchange for the sum of four-hundred thousand (\$400,000.00) U.S. Dollars, which is payable in the form of a non-convertible promissory note, bearing 8% interest per annum. The duration of the note is 12 months, at which time the note is due in full, along with any accrued interest. The closing of this agreement is effective immediately upon signing.

In addition, the parties agree that the Company will provide Shanghai Hua Si Tai Medical Consultation Company Limited with working capital in the sum of four-hundred thousand (\$400,000.00) U.S. Dollars during the 12 months following the signing of this agreement.

Shanghai Hua Si Tai Company owns and operates Shanghai based Vital Strategic Research Institute (VSRI). VSRI is a medical research firm with a long history of expertise in design, clinical trials and global research. VSRI has collaborated with pharmaceutical giants such as Pfizer and Bristol-Myers Squibb.

For the fiscal year 2016, Shanghai Hua Si Tai Company posted a net profit of one-hundred and sixty-five thousand (\$165,000.00) U.S.Dollars, compared to the fiscal year 2015, when it posted a net loss of one-hundred thousand (\$100,000.00) U.S.Dollars. Operating income for fiscal year 2016 was six-hundred and ninety thousand (\$690,000.00) U.S.Dollars.

The Company converted the profit and operating figures for Shanghai Hua Si Tai Company into U.S. Dollars from Chinese RMB and its financial statements will be audited by the Company's U.S. auditor.
