### **Change of Control**

As reported on the last quarterly report filed on 04/05/2018, the Company issued 2,000,000 shares of common stock to Lowell Holden on February 13, 2018 for the conversion of \$5,000 of debt that resulted in Change of Control of the company. Lowell Holden became the controlling person of the Company.

As reported on the last quarterly report filed on 04/05/2018, the Company issued 100,000,000 shares of common stock to Daniel Serruya on March 20, 2018 for subscription investment of \$10,000 that resulted in another Change of Control of the company. Daniel Serruya became the controlling person of the Company.

### **Amended Articles of Incorporation**

On March 19, 2018 the Company amended the Articles of Incorporation increasing the number of authorized shares of common stock to 500,000,000 and number of preferred shares to 50,000,000 each with a par value of \$0.0001.

### **Appointment of Director and Officer**

On March 26, 2018 Daniel Serruya was appointed as director and officer of the company. On March 26, 2018 the Board of directors of the company consisted of the following Individuals:
