CHANGE IN SHELL COMPANY STATUS

Bounce Mobile Systems, Inc. (the "Company" or "BNCM") was previously a shell company. The company is changing its status as shell company. Effective September 15, 2021, the company ceased to be a shell company.

As defined in Rule 405 under the Securities Act and Rule 12b-2 under the Exchange Act, a shell company is a company with (1) no or nominal operations, and (2) has any one of the following: (i) no or nominal assets, (ii) assets consisting solely of cash and cash equivalents; or (iii) assets consisting of any amount of cash and cash equivalents and nominal other assets.

The Company now has more than nominal operations and more than nominal assets through its ownership of assets and or shares in various companies involved in asset management, education, healthcare, and technologies, companies of which are located and or registered in Asia, Australia, New Zealand, and the United States.

BNCM Has More Than Nominal Business Operations Through Subsidiaries' Revenue

The assets of Bounce Mobile Systems, Inc. (BNCM) were injected from various Memorandum of Agreement with clients and thru consideration received in exchange of shares issued in favor of the new owner / chairman, Hatadi Shapiro Supaat. The unaudited revenue of BNCM for the interim period ending September 15, 2021 is **\$43,877,174.86**.

BNCM Has More Than Nominal Non-Cash Assets Through Each of Its Subsidiaries

The assets of each company acquired by BNCM are listed below:

- 1. Bounce Mobile Systems, Inc. has current assets of \$\frac{\\$100,000.00}{\} of cash (undeposited checks) based on interim balance sheet ending September 15, 2021.
- 2. Bounce Mobile Systems, Inc. has non-current assets of <u>\$124,853,570.54</u> of Investments/Acquired Co., Shares Receivable, Digital Assets (Token) and Digital Assets (NFT) based on interim balance sheet ending September 15, 2021.
- 3. Bounce Mobile Systems, Inc. has liabilities of \$95,547.38 of Advances from Officer based on interim balance sheet ending September 15, 2021.

In consideration of the Company's more than nominal business operations and more than nominal non-cash assets, the Company is not a shell, and we respectfully request that OTC Markets Group remove the "shell" designation from the profile of Bounce Mobile Systems, Inc. (the "Company" or "BNCM").
